Property Details

Adjacent to US 169 Highway, these parcels are owned by the City of Osawatomie. Tracts 1a and 1b are zoned with a mixture of industrial and commercial. Tracts 2, 3 and 4 are zoned industrial. All have direct access to a divided, four-lane highway that connects the Port of Catoosa in Tulsa, OK, to northern Minnesota.

The city is focused on pursuing opportunities that target industrial development, residential construction and renewable energy. The land is currently used for agricultural purposes. During 2020, Phase I environmental assessments were completed on each tract. Soil borings have been taken on tracts 2, 3 and 4.

Site Summary

The Northland Development includes tracts 1a and 1b which are located on the east side of US 169 Highway. In this area the city anticipates light industrial, residential and commercial uses.

Tracts 2, 3 and 4 are set aside for heavier industrial uses. They are located to the west of US 169 Highway at 335th and Osawatomie Road.


Zoning is in place. Lots will be subdivided as needed to meet operational requirements.

In addition to owning the tracts, the city provides water, sewer and electric services. Natural gas and fiber connections are offered by multiple providers.

The Northland qualifies for New Market Tax Credits and the Federal Qualified Opportunity Zone. It is also designated as an Environmental Justice Area. The incentives offered by these programs may be layered with property tax exemptions and financing options such as Industrial Revenue Bonds and Tax Increment Financing.

Utility Providers

Electricity: City of Osawatomie is a municipal electric provider. The city provides power through power purchase agreements and operates its own generation. They are able to generate 17.6 MW, well over the community's peak load of 9 MW, providing customers with reliable service. The city can provide three-phase service through a high capacity feeder line. Based on a rolling average of the last 12 months, the total projected electric charge per kWh for a large demand user was 25.8% below Evergy.

Water and Sewer: City of Osawatomie is the municipal provider for this area and has capacity to service new customers. The city's monthly charge for water is \$11 per meter, plus \$4.90 per 1000 gallons of water for usage under 75,000 gallons per month. The city's monthly charge for sewer is \$28 per water meter and \$2.70 per 1000 gallons of water usage.

Natural Gas: Kansas Gas would service the site.

Telecommunications: Fiber connectivity is provided by multiple sources.

Incentives

City-Owned Utilities

The electric utility is owned and operated by the City of Osawatomie allowing negotiations for a competitive rate. Also provided, at no cost to its major customers, is an industry professional who works as a key account contact for the customer serving as a consultant during project development. This individual will be able to identify potential cost-savings that may improve the power profile and provide lower effective rates to the customer.

The city also operates the site's water and wastewater utilities.

Local Permit Fees

For qualified projects, the city would waive all building permit fees and may assist with upgrading or bringing city-owned utilities to the site.

Financing and Taxes

The city is willing to review all available financing mechanisms to determine which vehicle is a project's best fit. As part of that review, property taxes may be abated or reduced. All incentives offered will be subject to city council approval.

The location is within a Qualified Opportunity Zone and is eligible for New Market Tax Credits.

In addition, Miami County Commissioners manage a countywide incentive fund. These funds, about \$250,000, could be authorized by the commissioners to assist a community with improvements related to an economic development project.

Foreign Trade Zone

Miami County is a part of the Greater Kansas City Foreign Trade Zone (GKCFTZ) service area. The GKCFTZ is the regional grantee of the national Foreign Trade Zone program and sponsors both Foreign-Trade Zone No. 15 in western Missouri and Zone No. 17 in eastern Kansas.

A FTZ is a designated location that is outside of Customs territory for purposes of collection of U.S. Customs duties and fees. Companies that could benefit from operation within a FTZ include operations that import products for domestic distribution or export, or companies that import raw materials or component parts for processing, manufacturing or assembly activities for domestic consumption.

To help identify potential savings, the GKCFTZ will conduct an initial analysis of the company's current import volumes and value, duties and MPF fees, export volumes, scrap losses, potential inverted duty savings and other elements. The analysis also estimates costs to participate in the FTZ program, which differ based on the size and nature of the FTZ operation. Costs include first year application and activation, personnel training costs, grantee fee and U.S. Customs Bond.

If a company is interested in pursuing FTZ designation for its facility, the process is straightforward and can take as little as 30 days with a maximum time of five months, depending on the specific requirements of the facility. The GKCFTZ provides guidance on procedures to follow and can assist in preparing the application.



Educational Providers Within One Hour of the Site





Each community college offers cutomized, employer-directed training programs. This allows employers to train or retrain their employees in specific skills or provide access to general education courses that count toward a college degree. Fort Scott Community College's partnership with Miami County's school districs resulted in the creation of a technical training center. Neosho County Community College Campus offers a range of classes with a focus on healthcare and technical skills. Johnson County Community College offers a training center focused on commercial driver's license certifications along with workplace certificates. Their Olathe campus focuses on healthcare. KansasWorks provides free services for employers including job postings, pre-employment skill assessments and training for job seekers.
