MAJOR COMPONENTS OF A STRATEGIC PLAN (Step One)

Mission statement: The mission statement is an overarching, timeless expression of your purpose and aspiration, addressing both what you seek to accomplish and the manner in which the organization seeks to accomplish it. It's a declaration of why you exist as an organization.

Vision statement: This short, concise statement of the organization's future answers the question of what the organization will look like or be producing in five or more years.

Values statement or guiding principles: These statements are enduring, passionate, and distinctive core beliefs. They're guiding principles that never change and are part of your strategic foundation.

What is a mission statement in simple words?

A mission statement is a brief statement that outlines an organization's purpose, goals, and values. It serves as a guide for decision-making and helps to keep the organization on track.

What are the 3 parts of a mission statement?

Purpose: An explanation of the organization's reason for existing.

Vision: A description of what the organization wants to achieve in the future.

Values: A list of the core values that guide the organization's behavior and decisions.

What is a good mission statement?

A good mission statement is one that outlines the purpose and values of a company or organization. It should be succinct and clearly communicate the organization's goals and values. For example: "Our mission is to provide high-quality products and services that meet our customers' needs and exceed their expectations, while maintaining our core values of respect, integrity, and excellence."

From Dani Robbins with NonProfit Evolution:

"The Board sets – meaning discusses and votes to adopt or revise – the **mission statement**, which answers why your organizations exist.

The Board also sets the vision of the organization. A **vision statement** is a description of what the organization will look like at a specified time, usually 3-5 years, in the future. There are two minds in the field as to if a vision statements should be a utopian view such as "an end to hunger" or a more concrete view such as "to be the premier youth development organization." I lean toward the latter; I find it challenging to set goals to get to utopia.

The Board sets the **Organization's Values**. These are ideas that are valued by the staff and Board of an organization. That could be communication, collaboration or individual accomplishments (not usually both), honesty, high ethical standards, or a whole host of other things. Values are about how you conduct yourself; how you talk to and about your clients, students or staff. Values provide the framework for decision making."
