RESOLUTION 1050 – ACCEPTING DEPT. OF ENERGY ANNUAL REPORT AND DIRECTING THE FILING THEREOF – Director of Utilities, Terry Upshaw presented the Annual Electric Report. **Motion** made by LaDuex, seconded by Wright to approve Resolution 1050 – Accepting the 2021 Annual Electric Report to the U.S. Department of energy as submitted by staff as presented. RESOLUTION 1051 – AMENDING THE PERSONNEL POLICIES TO CODIFY THE JUNETEENTH HOLIDAY IN LIEU OF THE FLOATING HOLIDAY– In April, the City Council approved the observation of Juneteenth for the City of Osawatomie. ## **CITY MANAGER & STAFF REPORTS.**

Ed Beaudry – The City Council approved the repair of the Memorial Hall roof on July 28, 2022. Included in the winning bid from Wright Construction they would replace the hip girder joists, tie the remaining rafters back into the new hip and re-sheath the affected area on the Northwest Corner.

When Wright Construction began the work at the northwest corner, it was discovered the hip rafter was broken. Staff spoke with a Structural Engineer, who is familiar with this building. He stated the best option would be to completely replace the roof with engineered trusses, deck and shingles at a cost of \$300,000.00. Unfortunately, this is not in our budget.

A more in-depth inspection of the three exiting hip rafters will be performed during the removal of the soffit and facia. If work is required on the existing 3 rafters (sistering), this could cost approximately \$33,000.00. This cost is for material and labor. This is also not in the budget. The structural engineer confirmed that the sistering will work for the short term (making it look better). But if we want to maintain this structure in the long-term, we will need to invest approximately \$300,000.00 to replace the complete roof structure and we simply don't currently have those funds on hand to take on the project.

This building will continue to need repairs, the large cantilevered overhang is something special that building designers do not use because of the added weight on the rafters/ truss ends. Engineered beams and or steel trusses are being used more and more on these roof structures, which is why the replacement prices are so high.

We will come back with options and prices.

**RECOMMENDATION:** Approve Resolution 1053 – Authorizing the purchase of the transformers.

**DETAILS:** The city's commitment for the solar array that we just signed the PPA for is to provide the transformers and any support steel, disconnect switches and breakers to get the power produced from the facility into the city of Osawatomie's distribution system. We requested bids from our normal transformer suppliers and received two quotes. One bid is from Midwest Electric Transformer Services and is for new transformers, 1 - 5000 kVA transformer in the amount of: \$241,345 or 2 - 2500 kVA transformers at a price of \$109,415/ea. These transformers will come with a one-year warranty and have lead times of 48-50 weeks ARO or 39-41 weeks ARO. Freight is included in these prices. Price is valid for 15 days.

The second quote we received was from Jerry's Electric, Inc. and is for 2 - 2500 kVA remanufactured transformers at a cost of \$67,250/ea (total \$134,500). Lead time is 54-58 weeks. These transformers come with a 3-year warranty, freight is included in the price and the price is valid for 30 days.




