NEXT REGULAR MEETING – March 25th, 2021

Osawatomie, Kansas. February 11, 2021. The Council Meeting was held at Memorial Hall. Mayor L. Mark Govea called the meeting to order at 6:30 p.m. Council members present were LaDuex Dickinson, Diehm, Macek, Hampson, Wright and Walmann. Council member Cathy Caldwell was absent. City Staff present at the meeting were: City Manager Mike Scanlon, Assistant to the City Manager Sam Moon, City Clerk Tammy Seamands, Building Official Ed Beaudry, and Fire Chief Brian Love. Members of the public were: John Wastlund, Kari Bradley and Mike Moon.

INVOCATION. John Wastlund, Well Wesleyan Church

CONSENT AGENDA. Approval of February 11th Agenda; January 28th Council Minutes, Pay Application – Kansas Fiber Network, LLC - \$82,154.00, Pay Application – BG Consultants - \$9,711.00 – Wastewater, Pay Application -Zingre and Associates - \$490.00 – Trail, Pay Application – Dondlinger Construction - \$42,993.34. **Motion** made by LaDuex, seconded by Dickinson to Approve the Consent Agenda as presented. Yeas: All.

COMMENTS FROM THE PUBLIC.

John Wastlund– Well Wesleyan Church - Thank you for inviting and including the Ministerial Alliance in the Oz Commons negotiations. Good Friday Service is usually held at the Old Stone Church but with Covid it will be a little different this year. They will take all of the ministers and put it all together and stream the service. Wastlund has talked some with Fire Chief Brian Love about establishing a chaplaincy service for the Miami County area. He is planning on making a brochure with contact information and possibly partnering with a Chaplin out of Louisburg.

Mike Moon –is here to talk about water his son-in-law use to work at the water plant as an operator several years ago. He would come to the house and occasionally update Moon on the condition of the water plant. Moon knows that the plant is in terrible shape. He has been to the plant and taken a tour. The rumor going around was that the City would eventually join a PUA. Moon thinks that giving up our water rights is a bad idea and wants to encourage the council to explore every option – short term patch, full rebuild, decrease the size, or to look for other wholesale customers. This agenda packet talks about putting together a Water Study Committee and Moon would be happy to serve.

UNFINISHED BUSINESS.

ORDINANCE 3791 - PERMITTING OF CERTAIN FOWL WITHIN CITY LIMITS – **Motion** made by Macek, seconded by Walmann to approve Ordinance 3791 – Amending Chapter 2 of the City Code of the City of Osawatomie, Kansas amending existing section 2-101 and adding a new section 2-105 to permit the keeping of certain fowl in the City of Osawatomie, Kansas. Yeas: (6) Wright, Macek, Walmann, LaDuex, Dickinson and Diehm Nays: (1) Hampson. SALE OF CITY-OWNED PROPERTY –In December 2020 Resolution 825 was passed that authorized City Staff to Develop a Process for the Sale and Redevelopment of vacated city owned lots. An RFP was issued and two bids were received. **Motion** made by LaDuex, seconded by Walmann to approve the sale of 1010 6th Street to SSGK, LLC in the amount of \$1,000 and the sale of 100 Walnut Avenue to SSGK, LLC in the amount of \$1,000. Yeas: All. Wright abstained due to conflict of interest.

NEW BUSINESS.

RESOLUTION 843 -FINALIZING AN AGREEMENT WITH PRIORITY POWER MANAGEMENT, LLC FOR MUNICIPAL ELECTRIC CONSULTING SERVICES FOR 2021– **Motion** made by Hampson, seconded by Dickinson to approve Resolution 843 – Finalizing an agreement with Priority Power Management, LLC for Municipal Electric Consulting Services for 2021. Yeas: All.

RESOLUTION 844 – ACCEPTING THE 2021 STATE OF THE CITY WATER FACILITIES REPORT AS SUBMITTED BY THE CITY MANAGER – This resolution relates to appointing a Water Study Committee to look at the Water Treatment Facility and the Water Distribution System which are both in need of attention at the same time. The committee will most likely be made up of two council members and four community members. Council members Hampson and Diehm volunteered to be on the committee. Members of the community that have been asked to be on the committee are Mike Moon, Mark Fuchs, Gordan Schrader and a fourth to be determined. **Motion** made by Hampson, seconded by Dickinson to approve Resolution 844 – Accepting the 2021 State of the City Water Facilities report that has been submitted by the city manager. Yeas: All.

RESOLUTION 845– ACCEPTING THE PROPOSED CALENDAR OF WORK FOR THE REPAIR OF THE WASTEWATER TREATMENT FACILITY – The City is in the process of negotiating a consent agreement for the work that needs to be done at the Wastewater Plant and this calendar lays out the timeline for the work to be completed. **Motion** made by Macek, seconded by Hampson to approve Resolution 845 – Accepting the proposed calendar of work for the repair of the wastewater treatment facility. Yeas: All.

RESOLUTION 846 – DIRECTING THE CITY MANAGER TO ENTER INTO A FINAL AGREEMENT WITH ALWAYS & FUREVER MIDWEST ANIMAL SANCTUARY REGARDING THE OPERATION OF THE OSAWATOMIE MUNICIPAL ANIMAL SHELTER – **Motion** made by Hampson, seconded by Dickinson to approve Resolution 846 – Directing the City Manager to sign a final agreement with Always & Furever Midwest Animal Sanctuary to operate as contractor of the Osawatomie Municipal Animal Shelter. Yeas: (5) Walmann, LaDuex, Dickinson, Diehm, and Hampson. Nays: (2) Wright and Macek

RESOLUTION 847 – DIRECTING CITY MANAGER TO ENTER INTO CONTRACT WITH PAYCHEX PAYROLL SOLUTIONS – Paychex Payroll Solutions will help to streamline business processes related to producing a bi-weekly payroll and offers a cost savings. It will also eliminate much of the paper approvals and shuffling that we do every two weeks. **Motion** made by Dickinson, seconded by Diehm to approve Resolution 847 – Directing the city manager to enter into an agreement with Paychex Payroll Solutions for bi-weekly payroll services. Yeas: All.

RESOLUTION 848 – DIRECTING THE CITY MANAGER TO IDENTIFY ADDITIONAL FUNDS TO RENOVATE THE CITY FIRE STATATION – The Osawatomie Fire Department and Electric department shared a building from 1994 to the summer of 2019. At that time the fire department began renovating the building to include an in-house training room, an ADA compliant restroom, offices for the Fire Officers and administration, a day room for firefighters to use when manning the station, and a Emergency Operations Center for emergency operations when the need arises. All of the work completed to this point has been done by the firefighters. To finish the renovation the staff asked for bids. The low bidder was Legacy Contracting for \$70,442. In addition to that bid the fire department would require tables, chairs, desks, computers, cabinets and appliances which would make the cost \$110,000 when added to the Legacy bid. City Manager Scanlon stated that the City was able to fund \$55,000 out of the general fund to finish this project, but would need assistance from outside sources to finish the project. **Motion** made by LaDuex, seconded by Hampson to approve Resolution 848 – Directing the city manager to identify additional funds to renovate the city fire station. Yeas: All

COUNCIL REPORTS.

Lawrence Dickinson \sim the water report was interesting and it answered some questions that he had.

Karen LaDuex ~ The library board has identified a suitable candidate for the library director position. Sam Moon worked very hard on compiling and sorting the applications. Saturday there is a legislative coffee at the Osawatomie Highschool Auditorium.

Jeff Walmann \sim Dondlinger Construction has got he piers and footings for the bridge in construction. Triangle Builders is doing the Kiosk and the taskforce is working on information to go in the kiosk.

MAYOR'S REPORT – Last week Govea sat in on a zoom meeting with Representative Turner and other Mayors. Govea was able to get information and phone numbers for Turner's staff. The Mayor of Lawrence identified some of the things that they are working on and said that they are keeping an eye on Osawatomie and the Flint Hills Trail. They would like to be find a way to tie into the trail.

Govea also set in on the selection of the Oz Commons and wants to give thanks to MARC for helping to set that up. There were eight submittals for this project. Also, thanks to Sam Moon, Ed Beaudry and Kari Bradley for helping to set this up and to Karen LaDuex and Cathy Caldwell for sitting in on this along with the other committee members. Architect One was the firm that was selected. They want to tie in the history of Osawatomie to this project.

A special thanks to Ed Beaudry for helping to lay out the mountain bike course at the state hospital.

CITY MANAGER & STAFF REPORTS. – Scanlon and Beaudry are working on a presentation for the Kansas Department of Wildlife, Parks and Tourism. They are currently designing the mountain trail bike on the state hospital property. We will use a licensing agreement similar to the one that was used with the school district.

Working with MARC to finalize "scope of work" with Architect One for the Oz Commons project. Beaudry, Sam and Martin with MARC will finish that in the next couple of days and then send it to the MARC board for approval.

Most city employees have received their first Covid-19 shot with the second-round boosters occurring for the fire/pd next week. All city employees that have opted for the shots will be vaccinated by mid-March.

Staff is working on multiple grants – USDA grant for radios, Kansas Department of Housing for utility assistance and KDHE revolving loan and a few more.

RESOLUTION 849 – DECLARING A LOCAL STATE OF FINANCIAL EMERGENCY RELATING TO THE FEBRUARY 2021 ENERGY CRISIS. - Staff was notified on Tuesday afternoon that because of requirements of FERC (Federal Energy Regulatory Commission) that the City of Osawatomie would be required to make a payment based on our energy purchases from February 10th through February 16th. That purchase price is somewhere between \$700,000 and \$1,000,000 for that week. Miami County Commissions passed an emergency declaration yesterday related specifically for a financial crisis caused by the energy market. Motion made by Walmann, seconded by LaDuex to approve Resolution 849 – Declaring a local state of financial emergency related to the February 2021 Energy Crisis. Yeas: All.

RESOLUTION 850 – AUTHORIZING THE ISSUANCE AND DELIVERY OF \$400,000 PRINCIPAL AMOUNT OF TAXABLE NO FUND WARRANTS (ELECTRIC UTILITY SYSTEM) SERIES 2021, OF THE CITY OF OSAWATOMIE, KANSAS, FOR THE PURPOSE OF PROVIDING FOR EXTRAORDINARY EMERGENCY FUNDS OF THE CITY; AND PRESCRIBING THE TERMS AND DETAILS OF SAID WARRANTS - This will allow the city to issue no fund warrants for the benefit of the electric utility in the amount of \$400,000. It is thought that will be the equivalent of the two highest energy bills that we are expected to have from the periods of February 10th -16th and February 17- 23rd. Spiked utility losses are not FEMA eligible. The State of Kansas working with the League of Kansas Municipalities has proposed an interim solution which is HB 2429- which would allow cities to borrow from the State's idle funds at a rate of .25% but this is adjustable on a weekly basis as we understand it at this point. Mitch Walter with our bond counsel Gilmore & Bell discussed the Resolution 849 that was passed last Motion made by LaDuex, seconded by Dickinson to approve week and Resolution 850. Resolution 850 – Authorizing the issuance and delivery of \$400,000 principal amount of taxable no fund warrants (electric utility system), series 2021, of the City of Osawatomie, Kansas for the purpose of providing for extraordinary emergency funds of the city; and prescribing the terms and details of said warrants. Yeas: All.

EXCERPT OF BYLAWS OF KANSAS MUNICPAL ENERGY AGENCY ARTICLE V BOARD OF DIRECTORS

Section 5.1. Selection of Directors. The property and business of the Agency shall be managed by the Board of Directors of the Agency. The Board of Directors shall consist of two (2) Directors for each Member, provided that there shall be not less than seven (7) Directors. The Directors shall be selected by the governing bodies of the Members. In the event that the number of Members is less than seven (7), each Member shall be represented by the number of Directors which would constitute a Board of Directors of not less than seven (7) Members, provided that each Member shall select the same number of Directors. Each Member must designate the two (2) Directors as "Director-1" and "Director-2".

The term of each Director shall be for a period of two (2) years except that the initial term of a number equal to one half of the Directors, comprised of those individuals designated as Director-2, shall be selected to a term of one (1) year. Any Director selected by a Member may be removed at any time by the Member selecting the Director. Each Director so selected shall (a) reside within the territory served by the electric utility of the selecting Member; or (b) be an employee of the selecting Member. Each Director shall meet all other requirements of the Act and the Agreement. Any such selection (other than a replacement selection) shall occur prior to the annual meeting of the Agency. Written evidence of selection shall be forwarded by the City Clerk or other authorized official of the Member to the Agency in writing prior to the annual meeting. Each Director shall continue in office until a successor is selected in accordance with this *Article V*.

Section 5.2. Voting Powers. Each Member shall be entitled to one Director vote on the Board of Directors which shall be equal to the vote of every other Member. Such vote shall be cast on behalf of the Member by Director-1 of such Member, if present; if such Director-1 is not present then by Director-2. Other than actions required in *Article XII* hereof, all actions of the Board of Directors shall be made upon affirmative vote of a majority of the Directors entitled to vote and voting on such action.

Section 5.3. Compensation. Except as may be specifically authorized by the Board of Directors, no Director shall receive payment from the Agency for any time spent in attending meetings of the Board of Directors or otherwise conducting business of the Agency. To the extent that funds are available, the Board of Directors, the Executive Committee, or the General Manager may authorize payment of expenses for travel in connection with the business of the Agency for other than meetings of the Board of Directors pursuant to the Act.

Section 5.4. Vacancies. In the event of a vacancy on the Board of Directors the appropriate Member shall select an individual to fill such vacancy for the remainder of the term in accordance with the same procedure as set forth for the selection of the initial Director. Written evidence of selection shall be provided to the Agency before voting privileges will take effect.

Section 5.5. Removal or Resignation. A Director may be removed only by the governing body of the Member selecting such Director. Any Director may resign by providing notice to the governing body of the Member the Director represents. The governing body shall certify to the Agency such removal or resignation of a Director.

Section 5.6. Successor Director. Upon removal or resignation of a Director, a successor Director will be selected by the governing body in the same manner as the original Director was selected, and the successor Director will be certified by the governing body to the Agency in the same manner as the original Director was certified. The successor Director shall serve for the remainder of the unexpired term of the original Director, subject to the rights of the governing body and such successor Director under **Section 5.5** of these Bylaws.

Section 5.7. Alternates. Each Member shall designate an Alternate or Alternates for the Director in the same manner as the Directors are designated. In the event any Director is unable to attend a meeting, any duly appointed Alternate may substitute at the meeting of the Board of Directors for such Director. The Member shall provide the Agency with written notification of the selection of such Alternate or Alternates. In the event neither Director designated by the Member is present, the Alternate may vote on behalf of such Member unless the governing body of the Member has specifically prohibited the Alternate from voting on the Member's behalf. If more than one Alternate is designated by the Member, the governing body shall specify in its designation the order in which the Alternates shall have voting rights on behalf of the Member.

DETAILS: Resolution 851 includes the following direction,

2. **Framework.** That the City Manager then develop a framework with at least three options for spreading the "Price Spike" over time.

3. **Presentation**. That the City Manager present to the City Council a framework and formal plan for the City Council to consider at their March 25, 2021 City Council meeting.

This resolution works in tandem with Resolution 850 that allowed for the issuance of **No Fund Warrants** and also with Resolution 852 and Ordinance 3794 that allow for the City to borrow funds from the **City Utility Low-Interest Loan Program** that will be considered at tonight's meeting as well.

Resolution No. 851

A RESOLUTION ESTABLISHING A FRAMEWORK FOR THE FUEL ADJUSTMENT ON CUSTOMER ELECTRIC BILLS CAUSED BY THE WEATHER EVENT OF MID-FEBRUARY.

WHEREAS, the City of Osawatomie, Kansas (the "City") owns and operates a municipal electric utility system (the "System"); and

WHEREAS, over a two-week period in February, historically low temperatures with sub-zero wind chills over several days, accompanied by snow, sleet, and freezing rain (collectively, the "Weather Event") across the state have significantly strained the regional energy infrastructure, including the increased demand for electricity and natural gas and decreased production of such resources over the same time period; and

WHEREAS, the Governor of the State of Kansas declared a State of Disaster Emergency Proclamation within the state on February 14, 2021; and

WHEREAS, the Board of County Commissioners for Miami, Kansas approved a resolution Declaring a State of Local Disaster Emergency on February 24, 2021; and

WHEREAS, the City Council for the City of Osawatomie, Kansas approved Resolution 849 Declaring a Local Financial Emergency on February 25, 2021; and

WHEREAS, as a result of the Weather Event, the cost to purchase essential natural gas and electricity exceeded 10 - 200 times the normal prices and the City was forced to pay higher costs to acquire electric energy to operate the System than it anticipated and budgeted and a resulting System revenue deficiency exists (the "Deficiency"); and

WHEREAS, the governing body of the City found and determined it to be necessary to provide for extraordinary emergency funds of the City to fund the required purchase of electricity for the System and to raise such funds by the issuance of No Fund Warrants of the System and its funds in an amount of not to exceed \$900,000, under authority of the Act; and

WHEREAS, the governing body of the City is contemplating the approval of Resolution 852 and Ordinance 3794 to take advantage of a \$100,000,000 short-term loan program that was established by the State of Kansas.

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF OSAWATOMIE:

SECTION 1. Calculation. That the City Manager determine the amount of the "Price Spike" in the electric utility in February, 2021.

SECTION 2. Framework. That the City Manager then develop a framework with at least three options for spreading the "Price Spike" over time.

SECTION 3. **Presentation**. That the City Manager present to the City Council a framework and formal plan for the City Council to consider at their March 25, 2021 City Council meeting

DETAILS: Resolution 852 works in tandem with Ordinance 3794 for to allow the City to borrow from the State of Kansas' City Utility Low-Interest Loan Program that was established in law last Wednesday, March 3, 2021.

RESOLUTION NO. 852

A RESOLUTION AUTHORIZING THE CITY OF OSAWATOMIE, KANSAS TO APPLY FOR THE CITY UTILITY LOW-INTEREST LOAN PROGRAM FOR THE PURPOSE OF OBTAINING A LOAN FROM THE STATE OF KANSAS TO FINANCE EXTRAORDINARY ELECTRIC COSTS INCURRED DURING THE EXTREME WINTER WEATHER EVENT OF FEBRUARY 2021.

WHEREAS, the health, safety, and economic well-being of our residents is the top priority for the governing body of the City of **39TOSAWATOMIE**, Kansas (the "City"); and

WHEREAS, on February 14, 2021, pursuant to the Kansas Emergency Management Act, Chapter 48, Article 9, of the Kansas Statutes Annotated, Governor Laura Kelly proclaimed a State of Disaster Emergency, recognizing power outages and critical energy supply shortages were anticipated; and

WHEREAS, during February 2021, the City faced a winter weather emergency that resulted in extraordinary electric costs; and

WHERAS, annually, the City budgets \$4,100,000 to cover the costs associated with electricity needs; and

WHEREAS, as of this date, the City estimates it will have an obligation to pay a total of \$4,800,000 in electricity as a result of the unprecedented prices charged during the extreme winter weather conditions in February 2021; and

WHEREAS, without emergency action and aid, the increased prices required to purchase natural gas and/or electricity will result in significantly higher than normal utility bills for the citizens of the City threatening the financial health and the physical welfare of the City's residents and businesses; and

WHEREAS, on March 3, 2021 Governor Laura Kelly signed into law House Substitute for Senate Bill 88, establishing the City Utility Low-Interest Loan Program and authorizing the State Treasurer to distribute up to \$100 million in loans for the purpose of providing loans to cities for extraordinary electric and/or natural gas costs incurred during the extreme winter weather event of February 2021.

THEREFORE, BE IT RESOLVED BY THE CITY OF 39TOSAWATOMIE, KANSAS AS FOLLOWS:

1. The City shall begin the process of borrowing funds in the amount of not to exceed \$700,000 from the State of Kansas through the City Utility Low-Interest Loan Program, to pay the extraordinary electric costs incurred during the extreme winter weather event of February 2021 (the "Extraordinary Costs"). The Governing Body hereby certifies that such amounts are attributable only to extraordinary electric costs incurred during the extreme winter weather event of February 2021 and not to any other utility costs previously budgeted for by the City

2. The Governing Body agrees to the following terms designed to ensure the lawful use of funds and transparency, equity, and accountability:

a. The loan shall be used only for those extraordinary electric costs incurred during the extreme winter weather event of February 2021 as certified by the Governing Body and not for any other utility costs previously budgeted for by the City.

b. The City requests that the term of the loan be for a period of not to exceed 10 years.

c. The interest rate on the loan shall be 2% below the market rate as provided in K.S.A. 75-4237, and amendments thereto, and shall be recalculated on the first business day of January of each year using the market rate then in effect. The minimum interest rate shall be 0.25% if the market rate is below 2.25%.

d. Payments on the loan will begin no later than July 1, 2021. The City requests the loan provide for semi-annual payment arrangements.

e. The City understands that the final terms of the loan, including amortization terms and repayment schedule, will be established through a loan agreement between the City and the State Treasurer's Office. Upon delivery to the City of the form loan agreement, the City will have 5 business days to return an executed loan agreement. In the event the City does not return an executed loan agreement, it will be required to repay the loan in full plus accrued interest. The plan for such repayment must be submitted to the State Treasurer within 5 business days of the City receiving the form loan agreement, and the repayment plan must be accomplished with all reasonable dispatch.

f. The City certifies that if the City receives any federal monies related to the extreme winter weather event of February 2021, the first priority for expenditure of such amounts (or any similar amounts received by the State of Kansas for the benefit of the City) will be the payment of any outstanding balance of the loan made to the City under the City Utility Low-Interest Loan Program as provided in Section 4(b) of the legislation creating the loan program. If the City receives any recoveries as a result of settlement or litigation or other refunds of Extraordinary Costs paid by the City that relate to the extreme winter weather event of February 2021, such amounts (or any similar amounts received by the State of Kansas for the benefit of the City) will be used to pay any outstanding balance of the loan made to the City under the City Utility Low-Interest Loan Program. The City will establish a dedicated source of revenue for repayment of the loan from rates, fees and charges for the use and services furnished by or through its related utility system.

3. The Mayor, Clerk and other City officials are hereby further authorized and directed to execute any and all documents and take such actions as they may deem necessary or advisable in order to carry out and perform the purposes of the Resolution, and to make alterations, changes or additions in the foregoing agreements, statements, instruments and other documents herein approved, authorized and confirmed which they may approve, and the execution or taking of such action shall be conclusive evidence of such necessity or advisability.

4. This resolution shall take effect and be in force immediately upon its adoption and shall remain in effect until future action is taken by the Governing Body.

AN ORDINANCE AUTHORIZING THE EXECUTION OF A LOAN AGREEMENT BETWEEN THE CITY OF OSAWATOMIE, KANSAS AND THE STATE OF KANSAS, ACTING BY AND THROUGH THE KANSAS STATE TREASURER FOR THE PURPOSE OF OBTAINING A LOAN PURSUANT TO THE CITY UTILITY LOW-INTEREST LOAN PROGRAM TO FINANCE EXTRAORDINARY ELECTRIC COSTS INCURRED DURING THE EXTREME WINTER WEATHER EVENT OF FEBRUARY 2021; ESTABLISHING A DEDICATED SOURCE OF REVENUE FOR REPAYMENT OF SUCH LOAN; AUTHORIZING AND APPROVING CERTAIN DOCUMENTS IN CONNECTION THEREWITH; AND AUTHORIZING CERTAIN OTHER ACTIONS IN CONNECTION WITH THE LOAN AGREEMENT.

WHEREAS, on March 3, 2021, Governor Laura Kelly signed into law House Substitute for Senate Bill 88, establishing the City Utility Low-Interest Loan Program and authorizing the State Treasurer to distribute up to \$100 million in loans for the purpose of providing loans to cities for extraordinary electric costs incurred during the extreme winter weather event of February 2021 (the "Act"); and

WHEREAS, the City of **39TOSAWATOMIE**, Kansas (the "City") has previously adopted Resolution No. 852 authorizing the City to make application to the State Treasurer for a loan pursuant to the City Utility Low-Interest Loan Program (the "Loan"); and

WHEREAS, the governing body of the City hereby finds and determines that it is necessary and desirable to accept the Loan and to enter into a loan agreement and certain other documents relating thereto, and to take certain actions required in order to implement such loan agreement.

THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF 39TOSAWATOMIE, KANSAS:

Section 1. Authorization of Loan Agreement. The City is hereby authorized to accept the Loan and to enter into a Loan Agreement with the State of Kansas acting by and through the State Treasurer (the "Loan Agreement") to finance the extraordinary electric costs incurred during the extreme winter weather event of February 2021 (the "Extraordinary Costs").

The Loan shall be in the amount of not to exceed \$700,000.

The interest rate on the loan shall be 2% below the market rate as provided in K.S.A. 75-4237, and amendments thereto, and shall be recalculated on the first business day of January of each year using the market rate then in effect. The minimum interest rate shall be 0.25% if the market rate is below 2.25%.

The Loan shall be repaid over a term of not to exceed 10 years. The City has requested semi-annual repayment dates.

The Mayor and Clerk are hereby authorized to execute the Loan Agreement, the Mayor's execution of the Loan Agreement being conclusive evidence of such approval.

Section 2. Establishment of Dedicated Source of Revenue for Repayment of Loan. The City hereby establishes a dedicated source of revenue for repayment of the Loan. In accordance therewith, the

City shall impose and collect such rates, fees and charges for the use and services furnished by or through its Electric utility (the "System"), including all improvements and additions thereto hereafter constructed or acquired by the City as will provide revenues which are sufficient to (a) pay the cost of the operation and maintenance of the System, (b) pay the principal of and interest on the Loan as and when the same become due, (c) pay all other amounts due at any time under the Loan Agreement and (d) pay the principal of and interest on all other outstanding bonds or indebtedness of the System; provided, however, no lien or other security interest is granted by the City to the State on the System revenues pursuant to the Loan. If the City receives any federal monies related to the extreme winter weather event of February 2021, the first priority for expenditure of such amounts (or any similar amounts received by the State of Kansas for the benefit of the City under the City Utility Low-Interest Loan Program as provided in Section 4(b) of the legislation creating the loan program. If the City receives any recoveries as a result of settlement or litigation or other refunds of Extraordinary Costs paid by the City that relate to the extreme winter weather event of February 2021, such amounts (or any similar amounts received by the City) will be used to pay any outstanding balance of the loan made to the City) will be used to pay any outstanding balance of the City Utility Low-Interest Loan Program.

In accordance with the Act, the obligations under the Loan and the Loan Agreement shall not be included within any limitation on the bonded indebtedness of the City.

Section 3. Further Authority. The Mayor, Clerk and other City officials are hereby further authorized and directed to execute any and all documents and take such actions as they may deem necessary or advisable in order to carry out and perform the purposes of the Ordinance, and to make alterations, changes or additions in the foregoing agreements, statements, instruments and other documents herein approved, authorized and confirmed which they may approve, and the execution or taking of such action shall be conclusive evidence of such necessity or advisability.

Section 4. Governing Law. The Ordinance and the Loan Agreement shall be governed exclusively by and construed in accordance with the applicable laws of the State of Kansas.

Section 5. Effective Date. This Ordinance shall take effect and be in full force from and after its passage by the governing body of the City and publication (or publication of a summary thereof) in the official City newspaper.

DETAILS: Miami County began the upgrading of all public safety radios in 2019. The total system cost was estimated at \$6.8 million. The Police Chief will be available to answer any questions related to the radios at the March 11th meeting.

RESOLUTION NO. 853

WHEREAS, the City of Osawatomie both depends on other agencies and provides other agencies with backup services; and

WHEREAS, without being on the same radio system makes it difficult if not impossible to coordinate services with outside agencies; and

WHEREAS, with the transfer of the City's dispatching operations to the County it's become even more critical to upgrade the public safety radios system,

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF OSAWATOMIE, KANSAS:

SECTION ONE: That the City complete the upgrade of all public safety radios to the new 800 MHZ system and do so in an expeditious manner.

SECTION TWO: That the City Manager working with the City's Finance Director complete all forms necessary to either secure loans or grants for the Radio System upgrade. This includes grants and loan applications to be presented to the United States Department of Agriculture (USDA).

Further, no Grantee or their representatives or contractors may commit non-HUD funds for an activity or project if the activity or project would have an adverse environmental impact or limit the choice of reasonable alternatives. Examples of choice limiting activities include acquisition of real property, demolition, construction, conversion, leasing, repair or rehabilitation activities. <u>Environmental reviews shall begin after the grant award date and must be cleared within six months from that date</u>. Be aware that should a contract not be executed with the State, any cost incurred toward a project will be borne by the Grantee.

STATE OF KANSAS GRANT AGREEMENT NO. 21-PF-027 between the

STATE OF KANSAS DEPARTMENT OF COMMERCE

and the

City of Osawatomie

I. Grant Agreement

A. This Grant Agreement, hereinafter called "Agreement," is between the State of Kansas, Department of Commerce, and its representative, hereinafter called "Department" and the City of Osawatomie, Kansas, hereinafter called the "Grantee." This Agreement consists of the body and the following: CONDITION LETTER (attached hereto as Attachment A), SPECIAL CONDITIONS (attached hereto as Attachment B), and the Grantee's APPROVED PROJECT APPLICATION dated JANURARY 25, 2021, (attached and incorporated by reference as Attachment C, a copy of which shall be maintained and available in the Department's files) and the GRANTEE HANDBOOK (which is attached and incorporated by reference as Attachment D).

II. <u>Authority</u>

- A. This Agreement is financed in part through a grant provided to the Department by the United States Department of Housing and Urban Development (HUD) under Title I of the Federal Housing and Community Development Act of 1974, as amended (42 USC 5301 et. seq.), hereinafter called "the Federal Act." As provided in the Federal Act, the State of Kansas, through the Department, has elected to administer the federal program of Small Cities Community Development Block Grants.
- B. The Department, in accordance with the provisions of K.S.A. 74-5001 et. seq., hereinafter called "the State Act," has approved the application of the Grantee and awarded funds for the purpose of supporting the Grantee's Community Development Program.
- C. In the event of changes in any applicable Federal regulations and/or law, this Agreement shall be deemed to be amended when required to comply with any law so amended.
- D. Federal Program Community Development Block Grant Cluster (CDBG) (CFDA No. 14.228).

III. <u>Description of Activities</u>

Grantee agrees to perform, or cause to be performed, the work specified in the APPROVED PROJECT APPLICATION.

IV. Period of Performance

The period of performance for all activities assisted by this Agreement shall commence on MARCH 1, 2021, hereinafter called the "Commencement Date," and shall be complete on FEBRUARY 28, 2023, hereinafter called the "Completion Date," except those activities required for close-out and final audit.

V. Compensation

- A. In consideration of the Grantee's satisfactory performance of the work required under this Agreement and the Grantee's compliance with the terms of this Agreement, the Department shall provide the Grantee the total sum of **\$600,000** in Community Development Block Grant funds. Such funds shall be used by the Grantee in accordance with the Activities listed and budgeted on the APPROVED PROJECT APPLICATION and the CONTRACT PROJECT BUDGET FORM.
- B. In addition, the Grantee shall provide **\$2,360,500** in other sources of funds to this Community Development Program and such funds shall be used by the Grantee in accordance with the Activities and budget on the APPROVED PROJECT APPLICATION.
- C. It is expressly understood and agreed that in no event will the total program funds provided by the Department exceed the sum of **\$600,000**. Any additional funds required to complete the program activities set forth in this Agreement will be the sole responsibility of the Grantee, and not the responsibility of the Department.

- D. The Grantee understands that this Agreement is funded in whole or in part by federal funds. In the unlikely event the federal funds supporting this Agreement become unavailable or are reduced, the Department may terminate or amend this Agreement and will not be obligated to pay the Grantee from State revenues.
- E. It is hereby agreed that funds committed to be provided by the Department are conditioned upon the availability and use of funds to be provided by the Grantee from other sources. In the event any portion of the funds required to be provided by the Grantee pursuant to subsection (B) of paragraph V. are not made available or used for activities as listed and budgeted, the Department may, in its discretion, withdraw or reduce proportionately the funds to be provided to the Grantee pursuant to subsection (A) of paragraph V.
- F. The Grantee shall not anticipate future funding from the Department beyond the duration of this Agreement and in no event shall this Agreement be construed as a commitment by the Department to expend funds beyond the termination of this Agreement.

VI. Indemnification

The Grantee shall indemnify, defend, and hold harmless the State and its officers and employees from any liabilities, claims, suits, judgments, and damages arising as a result of the performance of the obligations under this Agreement by the Grantee or any subgrantee, contractor, subcontractor, or person. The liability of the Grantee under this Agreement shall continue after the termination of the Agreement with respect to any liabilities, claims, suits, judgments, and damages resulting from acts occurring prior to termination of this Agreement.

VII. Obligations of Grantee

- A. All of the activities required by this Agreement shall be performed by personnel of the Grantee or by third parties (subgrantees, contractors, or subcontractors) under the direct supervision of the Grantee and in accordance with the terms of written contracts. Any such contracts may be made subject to approval by the Department.
- B. Except as may otherwise be provided in the SPECIAL CONDITIONS, the Grantee may subgrant, contract, or subcontract any of the work or services covered by this Agreement.
- C. The Grantee shall remain fully obligated and liable under the provisions of this Agreement, notwithstanding its designation of any third party or parties for the undertaking of all or any of the program being assisted under this grant.
- D. The Grantee shall require any third party to comply with all lawful requirements necessary to insure that the program is carried out in accordance with this Agreement.
- E. The Grantee shall comply with all timelines for completion of Grantee's Environmental Review and contracting responsibilities as established by the Department in the CONDITION LETTER.

VIII. Environmental Review Compliance

- A. The obligation and utilization of the funding assistance is subject to the requirements for a release of funds by the State under the Environmental Review procedures at 24 CFR Part 58 for any activities requiring such release.
- B. The Grantee agrees to assume all of the responsibilities for Environmental Review, decision making and action, as specified and required in Section 104(g) of Title I of the Housing and Community Development Act of 1974 (Public Law 93-383), as amended. The Grantee shall not allow any subrecipient to assume the grantee's Environmental Review responsibilities.

IX. Program Costs

- A. The Grantee may only incur such costs as are reasonable and necessary to the Grantee's Program and as are allowable under the Department's Procedures (2 CFR Part 200). Cost items not specifically authorized may only be incurred after written approval by the Department.
- B. Cash and in-kind contributions made by the Grantee shall follow the criteria established by the Department's Procedures.

- C. The total "Small Cities CDBG Funds" expended for "Administration" shown in the Contract Project Budget Form shall not exceed the approved amount unless amended by all parties to this contract.
- D. The Grantee shall not incur costs on any program activity until the Environmental Review required by 24 CFR 58 has been completed and the Department has issued the "Notice of Release of Funds."
- E. Any program activities performed by the Grantee in the period between notification of award and execution of this Agreement shall be performed at the sole risk of the Grantee. In the event this agreement should not become effective, the Department shall be under no obligation to pay the Grantee for any costs incurred or monies spent in connection with program activities, or to otherwise pay for any activities performed during such period. However, upon execution of this Agreement, all Program Costs incurred in connection with approved activities performed during this period shall be reimbursed in accordance with the terms and conditions of this Agreement.
- F. Grant funds may not, without advance written approval by the Department, be obligated after the Completion Date except for those activities required for close-out. Obligations incurred prior to and still outstanding as of the Completion Date shall be liquidated within ninety (90) days.
- G. At any time during the period of performance under this Agreement, and upon receipt of the progress and financial reports, Final Program Report or Final Audit Report, the Department may review all Program Costs incurred by the Grantee and all payments made to date. Upon such review the Department shall disallow any items of expense which are not determined to be allowable or are determined to be in excess of approved expenditures; and shall, by written notice specifying the disallowed expenditures, inform the Grantee of any such disallowance.
- H. If the Department disallows costs for which payment has not yet been made, it shall refuse to pay such costs. If payment has been made with respect to costs which are subsequently disallowed, the Department may deduct the amount of disallowed costs from any future payments under this Agreement or require that the Grantee refund the amount of the disallowed costs.

X. <u>Requisition of Grant Funds</u>

- A. Requisitions for cash advances shall be made on the established forms and shall not ordinarily be made more frequently than twice a month or in amounts less than \$3,000 and in no cases more than \$200,000.
- B. The Grantee shall establish procedures to insure that any amounts of cash in excess of the limits set forth in (A) above shall be expended within three (3) days of receipt of the funds in the depository account.
- C. Cash advances made by the Grantee to subgrantees shall conform substantially to the same standards of timing and amount as apply to the Grantee under this Agreement.
- D. Amounts withheld from contractor to assure satisfactory completion of work shall not be paid until the Grantee has received a final payment request from the contractor and has certified the work is complete and satisfactory.
- E. The Department may terminate advance financing and require the Grantee to finance its operations with its own working capital should it be determined that the Grantee is unwilling or unable to establish procedures to minimize the time lapsing between cash advances and disbursement. Payments to the Grantee would then be made only as reimbursement for actual cash disbursements.

XI. Depositories for Program Funds

- A. The Grantee shall maintain a separate record for money received under the Community Development Program. Into this fund shall be deposited:
 - 1. Moneys received from the Department.
 - 2. Program income earned through program activities.
- B. Any interest earned, prior to disbursement, on advances of grant funds shall be remitted to the State for subsequent return to the United States Treasury.

XII. Financial Management

- A. Grantees shall establish and maintain a system which assures effective control over and accountability for all funds, property and other assets used in the Community Development Program.
- B. Grantees shall either adopt the system recommended by the Department or certify to the Department, in writing, prior to making the first requisition of funds that the alternative system proposed for use shall meet the following standards:
 - 1. Maintenance of separate accounting records and source documentation for the Community Development Program;
 - 2. Provision for accurate, current and complete disclosure of the financial status of the Program;
 - 3. Establishment of records of budgets and expenditures for each approved activity;
 - 4. Demonstration of the sequence and status of receipts, obligations, disbursements and fund balance;
 - 5. Provision of financial status reports in the form specified by the Department;
 - 6. Compliance with the Department's audit requirements (2 CFR Part 200); and
 - 7. Consistency with generally accepted accounting principles as specified by the Kansas Department of Administration, unless a waiver of GAAP has been received by the Grantee from the Kansas Director of Accounts and Reports.

XIII. Monitoring and Reporting

- A. The Grantee shall monitor the activities of the Community Development Program, including those of contractors and subcontractors, to assure that all program requirements are being met.
- B. The Grantee shall submit progress and financial reports to the Department in accordance with the schedule set forth in the SPECIAL CONDITIONS. These reports shall be in a format prescribed by the Department.
- C. The Grantee shall submit a Final Program Report with the close-out no later than ninety (90) days following the Completion Date.
- D. From time to time, as requested in writing by the Department, the Grantee shall submit such data and other information as the Department may require.
- E. Failure to report as required or respond to requests for data or information in a timely manner may be grounds for suspension or termination of the Grant.

XIV. Procurement Procedures

- A. The Grantee shall use established procurement procedures which reflect applicable State and local laws and regulations and the Department's Procedures for the establishment of procurement systems.
- B. These standards do not relieve the Grantee of any contractual responsibilities under its contracts. The Grantee is responsible, in accordance with good administrative practice and sound business judgment, for the settlement of all contractual and administrative issues arising out of procurements entered into support of a grant. These include but are not limited to source evaluation, protests, disputes, and claims.

XV. Bonding Requirements

A. When administering federal grants and subgrants, a Grantee may follow its own requirements and practices with respect to: (1) bonding of employees and contractors, and (2) insurance. Federal grantor agencies are not permitted to impose requirements beyond those listed below. The government-wide grants management common rule, "Uniform Administrative Requirements for Grants to State and Local Governments," contains bonding requirements only for circumstances when a grantee contracts for construction or facility improvement (including alteration and renovation) and the bids and contracts exceed \$25,000. The following types of bonds are required in the "Procurement" section of the common rule:

- A 100 percent "performance bond" on the part of the contractor to secure fulfillment of all the contractor's obligations under the contract; and
- A 100 percent "payment bond" on the part of the contractor to assure payment, as required by law, of all persons supplying labor and materials as part of work provided under the contract.
- B. The Department reserves the right to promulgate and enforce bonding procedures and requirements applicable to any project.
- C. All bonds shall be procured from a surety company registered and licensed to do business in the State of Kansas and countersigned by its Kansas resident agent.

XVI. Program Income

- A. Program Income, as defined in the Final Statement, means gross income earned by the Grantee from activities supported by grants made by the Department under the provisions of the Federal Act, or as otherwise defined by the Department.
- B. All Program Income from a project funded by this Agreement may be retained by the Grantee (unless specified as a Special Condition to this agreement) and shall be added to funds committed to the support of the program established by this Agreement or for such eligible program activities as may be authorized by the Department. This income shall be disbursed to the maximum extent feasible prior to requisitioning additional funds under this agreement.

XVII. Program Close-out Procedures

- A. Program close-out is the process by which the Department determines that all applicable administrative and financial actions and all required work of the program including audit and resolution of audit findings have been completed or that there are no additional benefits likely to occur by continuation of program activities or costs. All findings from Department monitoring visits must be cleared prior to close-out.
- B. The Completion Date is the date specified in Section IV., Period of Performance, of this Agreement or amendment thereto, on which assistance ends for all program activities except those required to complete the close-out or the date on which the grant is suspended or terminated.
- C. The Grantee shall submit to the Department close-out documents covering the entire program within ninety (90) days of completion date. Additionally, one copy must be placed where other program documents are available for public review, and at least one copy must remain in the Grantee's files. The Department may grant extensions to the time for submission of these documents when so requested by the Grantee in writing.
- D. The Department retains the right to recover any appropriate amount of unobligated program funds.
- E. The Grantee shall account for any property acquired with grant funds, or received from the federal or state government in accordance with the Department's property management procedures.

XVIII. Termination for Convenience

- A. The Department or Grantee may terminate the grant in whole, or in part, when both parties agree that the continuation of the program would not produce beneficial results commensurate with the further expenditure of funds.
- B. The two parties shall agree upon the termination conditions, including the effective date and, in the case of partial terminations, the portion to be terminated.
- C. The Grantee shall not incur new obligations for the terminated portion after the effective date, and shall cancel as many outstanding obligations as possible. The Grantee shall be allowed full credit for noncancelable obligations, property incurred prior to termination.

XIX. Suspension or Termination-for-Cause

- A. The Department may suspend the grant, in whole or in part, at any time during the Grant Period, and upon reasonable notice to the Grantee withhold further payments or prohibit the Grantee from incurring additional obligations of grant funds when it is determined that the Grantee has failed to substantially comply with the conditions of this Agreement. This will be done pending corrective action by the Grantee or a decision by the Department to terminate the grant. The Department shall allow all necessary and proper costs which the Grantee could not reasonably avoid during the period of suspension.
- B. The Department, after reasonable notice following procedures pursuant to Final Statement may terminate the grant, in whole or in part, at any time during the Grant Period when it is determined that the Grantee has failed to substantially comply with the conditions of this Agreement. The Department shall promptly notify the Grantee in writing, of the determination and the reasons for the termination, together with the effective date and may initiate procedures to recapture all funds advanced to Grantee.
- C. Payments made to the Grantee or recoveries by the Department under grants which have been suspended or terminated for cause shall be in accord with the legal rights and liabilities of the parties.

XX. Audit Requirements

- A. The Grantee shall arrange for the performance of annual financial/compliance audits of the grant project. All audits must be performed by an independent qualified auditor. The audit period is identical with the Grantee's regular fiscal year. The audit(s) will be conducted in accordance with the requirements set forth in the audit section of the Kansas CDBG Handbook, which are based on 2 CFR Part 200.
 - 1. If the local government expends \$750,000 or more of Federal grant assistance from all programs, it must have an annual audit performed in accordance with 2 CFR Part 200. An audit is a financial and compliance audit that covers the entire operations of the local government, rather than being limited to the CDBG project or other Federal grants.
 - 2. If the local government expends less than \$750,000 in a fiscal year, it will be the option of the Department of Commerce to determine if a project specific audit will be required. If such audit is required, it will be procured and paid for by the Department.
 - 3. Grantee's will be required to submit the "audit information form" to the Department of Commerce each fiscal year. This form must be submitted to the Department by or before May 15th of each fiscal year.
- B. Grantees are required to submit one copy of a fiscal year audit report covering the program. The audit reports shall be sent within 30 days after the completion of the audit, but no later than the nine months after the end of the audit period unless agreed to by the Department.
- C. If any expenditures are disallowed as a result of the Final Audit Report, the obligation for reimbursement to the Kansas Small Cities Community Development Block Grant Program shall rest with the Grantee.

XXI. Retention of and Access to Records

- A. Financial records, supporting documents, statistical records, and all other records pertinent to this program shall be retained in accordance with the Department's Procedures.
- B. Authorized representatives of the Department, the Secretary of HUD, the Inspector General of the United States, or the U.S. General Accounting Office shall have access to all books, accounts, records, reports, files, papers, things, or property belonging to, or in use by, the Grantee pertaining to the administration of these grants and the receipt of assistance under the Small Cities CDBG program as may be necessary to make audits, examinations, excerpts, and transcripts for a period of three years after the <u>entire State CDBG grant year you were awarded from has been closed out by HUD</u>.
- C. Any contract or agreement entered into by the Grantee shall contain language comparable to subsection (B) so as to assure access by authorized parties to the pertinent records of any subgrantee, contractor, or subcontractor.

XXII. Conflict of Interest

- A. In the procurement of supplies, equipment, construction and services by Grantees and subgrantees, the conflict of interest provisions of the Kansas Department of Commerce as provided at 2 CFR Part 200 shall apply.
- B. No member of the Governing Body, officer or employee of the Grantee, or its designees or agents, or any other person who exercises any functions or responsibilities with respect to the program assisted by this Agreement during his tenure or for one year thereafter, shall have any direct interest in any contract or subcontract, or the proceeds thereof, for the work to be performed in connection with the program.
- C. The Grantee shall incorporate, or cause to be incorporated, in all third party agreements, a provision prohibiting such interest pursuant to the purpose of this Section.
- D. The Grantee shall not employ, nor shall permit any third party to employ any employee of the Department.

XXIII. Equal Opportunity

In addition to all equal opportunity provisions and the Assurances incorporated by reference herein, the Grantee agrees to comply with all of the requirements of the Kansas Acts Against Discrimination relating to fair employment practices, to the extent applicable and shall cause the foregoing provisions to be inserted in all contracts with third parties for any work covered by this Agreement so that such provisions will be binding upon such third parties.

Grantee will conduct and administer the grant in conformity with Title VI of the Civil Rights Act of 1964 (42 USC 2000d et seq., as amended) and the Fair Housing Act (42 USC 3601-20) and will affirmatively further fair housing.

XXIV. Waiver of Enforcement

A waiver by the Department of the right to enforce any provision of this Agreement shall not be deemed a waiver of the right to enforce each and all of the provisions herein.

XXV. <u>Reversion of Assets</u>

- A. Consistent with the provisions at 24 CFR 570.703, the Grantee shall transfer any CDBG funds on hand at the time of expiration of the Agreement and any accounts receivable attributable to the use of CDBG funds to the Department.
- B. Any real property under the Grantee's control that was acquired or improved in whole or in part with CDBG funds in excess of \$25,000 shall be used for its original intended purpose for five years after expiration of the agreement. Should the Grantee fail to utilize said property for its intended purpose, the Grantee shall pay the Department an amount equal to the current market value of the property less any portion of the value attributable to expenditures of non-CDBG funds for the acquisition of, or improvement to, the property.

XXVI. Budget Amendments and Other Changes

- A. During the implementation of the grant project, the Grantee may revise the CDBG activities amounts in the CONTRACT PROJECT BUDGET FORM; provided that:
 - 1. The cumulative effect of the revision is to not make line item budget transfers which exceed ten percent of the total grant or \$10,000 cumulative of CDBG monies, whichever is less.
 - 2. The change does not increase any professional services of the CDBG approved budget;
 - 3. The change will not significantly change the scope, location or objectives of the approved activities; and
 - 4. The change does not add or eliminate any activity.
- B. Any such changes to this Agreement shall constitute an amendment, including time extension of the completion date.

- C. The Grantee shall notify the Department if, through the use of other funds, there is an intention to expand, enhance or add to the scope of the program covered by the Agreement, or there is a proposal to undertake activities that will have an impact upon the buildings, areas or activities of this program. The Department reserves the right to require an amendment to this Agreement if such is deemed necessary.
- D. Amendments to the terms and conditions of this Agreement shall not become effective unless reduced to writing, applicable standard forms submitted in duplicate, passed by Resolution of the governing body, and signed by the duly authorized representative of the Grantee, and signed by the Department.
- E. I hereby certify that I have knowledge of all activities in the above-referenced grant. I also certify that I am aware that the regulations of the CDBG program prevent the use of any facility built or rehabilitated with CDBG funds, or any portion thereof, to be used for the conduct of official business. By accepting the above-referenced grant award, I certify that no portion of the above grant award violates this regulation.

Copies or originals of all CDBG recipient files and documentation must be maintained at the recipient's principal place of business.

- 2. As provided in Section XIII., <u>Monitoring and Reporting</u>, B., the Grantee shall submit Quarterly Progress Reports to the Department. The reporting periods consist of January/February/March, April/May/June, July/August/September and October/November/December. Quarterly Progress Reports are to be submitted to the Department on or before ten (10) days after the end of each quarter. A Quarterly Progress Report shall be submitted for each quarter, or portion thereof, during the <u>Period of Performance</u> as provided in Section IV. Any extension of time approved by the Department will require additional Quarterly Progress and Financial Reports to be submitted in accordance with the above-referenced schedule.
- 3. As provided in Section IV., <u>Period of Performance</u>, all activities assisted by this Agreement shall be completed on **FEBRUARY 28**, **2023** except for those activities required to close out the program, such as the Final Program Report and the Final Audit Report.
- 4. As provided in Section XIII., <u>Monitoring and Reporting</u>, C., the Grantee shall submit a Final Program Report to the Department on or before **MAY 28**, 2023.
- 5. The Grantee shall not use funds that have been granted by HUD under the Federal Act, or which may have been accrued as a consequence of activities supported with such grant funds (program income), in whole or in part for the support of the Activities covered by this Grant Agreement without first having secured the express written approval of HUD.
- 6.
