STAFF AGENDA MEMORANDUM

DATE OF MEETING: July 14, 2016

AGENDA ITEM: Proposed Condemnations

PRESENTER: Don Cawby, City Manager

ISSUE SUMMARY: On April 28, Resolution No. 719 was passed scheduling a hearing for tonight, June 23rd, at which the owners, the owners' agents, any lienholders of record, any occupants and other parties in interest, as that term is defined by law, of the nine proposed properties for condemnation. City staff presented detailed reports on nine recommended properties for the City Council that it believed were eligible, or on their way to being eligible for condemnations.

On June 23, the City Council conducted hearings for the properties listed below to make a determination whether a resolution should be drafted and what findings of fact should be included.

110 Brown	222 Lincoln	317 Mill
334 Main	427 Lincoln	805 Chestnut
917 Pacific	1003 Chestnut	1635 Main

After the hearing, the City Council directed that resolutions be drafted for all of the properties, with the exception of 110 Brown. The owner of 110 Brown had made significant improvements to the property since receiving the condemnation hearing notice in May.

Staff has drafted resolutions with findings of fact and put them on the agenda to be considered at this meeting. As always, we have included the following to help explain how a non-emergency condemnation occurs.

Procedure for Condemnations

1. First step is to have the enforcing officer file a written statement that is presented to the governing body that describes the property, where the property is located and that the property is unsafe or dangerous or is abandoned. Often these reports are accompanied by photos of the property to help illustrate why the property is abandoned, unsafe or dangerous.

- 2. Governing Body passes a Resolution that fixes a time and place at which the owner, the owner's agent, any lienholders of record and any occupant of such structure may appear and show cause why such structure should not be condemned and ordered repaired or demolished in the case of unsafe or dangerous structures or rehabilitated in the case of abandoned property.
- 3. Resolution is published once each week for two consecutive weeks on the same day of each week.
- 4. The matter is set for hearing before the Governing Body at least thirty days after the date of the last publication.
- 5. A copy of the Resolution is mailed by certified mail within three days after its first publication to each such owner, agent, lienholder and occupant at the last known address with the letter marked as "deliver to addressee only."
- 6. At the date set for the hearing the Governing Body hears all evidence submitted by the owner, the owner's agent, lienholders of record and occupants having an interest in the structure as well as evidence submitted by the enforcing officer filing the statement.
- 7. Governing Body makes findings. If the Governing Body finds that the structure is unsafe or dangerous such resolution shall direct the structure to be repaired or removed and the premises made safe and secure. If the Governing Body finds that the property is abandoned, the governing body may authorize the rehabilitation of the property as provided by K.S.A. 12 1756a.
- 8. Resolution containing findings is published once in the official city paper and a copy mailed to the owners, agents, lienholders of record and occupants in the same manner provided for the notice of hearing, i.e., certified mail within three days of the publication of the Resolution to last known address marked as "deliver to addressee only."
- 9. Resolution should fix a reasonable time within which the repair or removal of the structure shall be commenced and a statement the if the owner of such structure fails to commence the repair or removal of such structure within the time stated or fails to diligently prosecute the same until the work is completed, the governing body will cause the structure to be repaired or razed and removed in the case of unsafe or dangerous structures or rehabilitated in the case of abandoned property.
- 10. If the owner fails to commence the repair or removal of the structure within the time stated in the resolution or has failed to diligently prosecute the same thereafter, the city may proceed to raze and remove such structure, make the premises safe and secure, or let the same to contract. The City shall keep an account of the cost of such work and may sell the salvage from such structure and apply the proceeds or any necessary portion thereof to pay the costs of removing such structure and making the premises safe and secure. Any money is excess of the costs shall be paid to the owner of the premises upon which the structure was located.

11. The City shall give notice to the owner of the structure by restricted mail of the total costs incurred by the city in removing the structure and making the premises safe and secure and providing notice. The notice shall state that payment of such cost is due and payable within 30 days following receipt of such notice. If the cost is not paid with the thirty-day period and if there is not salvageable material or if money received from the sale, the balance shall be collected in the manner provided by K.S.A. 12-1,115 or assessed as a special assessment against the lot or parcel. See 12-1755 for procedure.

COUNCIL ACTION NEEDED: Consider each resolution separately and adjust the terms or dates as necessary by simple motion.

STAFF RECOMMENDATION TO COUNCIL: Approve the resolutions with one exception and one consideration. First, staff recommends removing the resolution for 427 Lincoln as there is a pending purchase of the property by the neighbor with plans to demolish the trailer by no later than the end of the year. Second, staff recommends the Council consider additional information concerning exterior cleanup work that has been done on 1635 Main since the June 23 hearing, in accordance with advice given to the owner at the meeting.

WHEREAS, on the 23rd day of June, 2016, the Governing Body did conduct the hearing scheduled in Resolution No. 719 and took evidence from the following: the Enforcing Officer on behalf of the City, Ted Bartlett. The following parties in interest failed to appear or appeared and did not present evidence: Franklin Austin Jr. and Marie Austin.

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF OSAWATOMIE, KANSAS, THAT:

- 1. The Governing Body hereby finds that the structure located at Lots 16, 17, 18, 19, 20, In Block 13, Lasher's Addition to the City Of Osawatomie, Miami County, Kansas; Commonly Known and Referred To as **222 Lincoln Avenue**, Osawatomie, Kansas is unsafe and dangerous based on the following findings:
 - a) Structure is a trailer, where the rim joist is visible, rotten and hanging down, aluminum siding is falling off or missing and has been replaced in places mismatched with wooden type siding, and nearly all skirting is missing.
 - b) Insulation is exposed and visible from underneath the structure.
 - c) The structure has signs of visible water damage from a leaking roof.
 - 2. The owner of such structure is hereby directed to commence the removal of the

property within 14 days from the date of publication of this resolution, and to have the removal completed within 30 days of the commencement. Provided, that upon due application by the owner and for good cause shown, the Governing Body, in its sole discretion, may grant the owner additional time to complete the removal of the property.

3. If the owner fails to commence the repair of the structure within the time stated herein, or any additional time granted by the Governing Body, or fails to diligently prosecute the same until the work is completed, the Governing Body will cause the structure to be razed and removed and the costs of razing and removing, less salvage if any, shall be collected in the manner provided by K.S.A. 12-1755, and amendments thereto or shall be assessed as a special assessment against the lot or parcel of land upon which the structure is located or by both, all as provided by law.

ISSUE SUMMARY: As part of the Electric Generation Project, we have planned for three different levels of service agreements with an authorized CAT dealer, in order to maintain the integrity of the units under the current and extended warranties.

Work on five of the units will be approximately \$16,000 each and the repair of unit #2 will be approximately \$37,000. Since these are estimates and not firm numbers, the costs could vary either way. We are recommending we proceed with this work so that we can load test all the units and have them approved for extended warranties. Should any of the units fail, the necessary work will be covered by the current warranty.

Service Agreements. In order to have a warranty on the units, they will all need to be under a service agreement with CAT that ensures fluid levels are monitored, filters are being checked and replaced, and that the oil is changed at least once every three years. We have looked over several agreements, but we believe a 3 year, annual inspection with one oil change is the best option for the City. We are still finalizing the final numbers, but we need to have these agreements in place before we start the engines and operate under the current warranty.

The table above shows the four quotes we received from Foley CAT. We have only included the first two quotes in the packet and will be seeking a hybrid of these offers, with the cost expected to fall between the two totals.

Extended Warranties. We have not received final agreements on the extended warranties and we still have time to bring those agreements back to the Council. However, we are still negotiating these arrangements and expect the options be the following:

24 Month \$7,110.00 per unit 36 Month \$11,380.00 per unit 48 Month \$14,876.00 per unit

Impact on Project. All three of these items were included in the project budget and cumulatively, they all fall within the current budget. However, the costs are allocated differently to the different line items with the warranties and repairs to the #2 unit costing less than expected and the start-up costs costing more. Included is an updated budget with the service agreement costs included.

COUNCIL ACTION NEEDED: Consider the agreements as presented.

STAFF RECOMMENDATION TO COUNCIL: Authorize the City Manager to approve service work with Foley CAT for start-up costs based on the included estimates, not to exceed \$90,000 for all related start-up costs.

Also, authorize the City Manager to sign a service agreement with Foley CAT not to exceed \$150,000 for the estimated start-up and load testing of all six units.


ISSUE SUMMARY: Tri-Ko is currently developing plans to substantially expand their facility here in Osawatomie. The expansion will require an increase in property lines and Tri-Ko has inquired about the possible acquisition of the property east of the main campus, owned by the City of Osawatomie. This property would be necessary to accommodate the new growth expansion. Tri-Ko believes, at one point, they had an agreement with the City to acquire the property however, the process was never completed. It is now their wish at to complete the process and proceed with their expansion.

With the addition of the City property, Tri-Ko's property will increase by approximately 40%. If council decides to grant Tri-Ko the property, the City will need to clarify the property lines around Industrial Drive. The City would also require utility and drainage easements across both properties.

If the request for the property be granted to Tri-Ko, the City would require the right of way through Industrial Drive to be restored by way of a 50 ft. easement along the road from the center of the both the city and current Tri-Ko property. For the circle drive radius, the City would request about a 60 ft. radius (120 ft. diameter) around the circle drive. That should put it close to the east property line on the east side. Finally, we would want about the same 50 ft. attachment (like the road continues without a radius) on the east side of the circle so we can access the cemetery from the west if we need to.

COUNCIL ACTION NEEDED: Review and discuss. Provide direction to staff.

STAFF RECOMMENDATION TO COUNCIL: Grant Tri-Ko the property and proceed with the development of utility and drainage easements.

As always, Tri-ko takes tremendous pride in our relationship with this community and its leaders, and is sincerely grateful for your careful consideration and continued support.


