SPECIAL MEETING – August 6, 2015 REGULAR MEETING – August 13, 2015 REGULAR MEETING – August 27, 2015 Osawatomie, Kansas. **June 11, 2015.** The Council meeting was held in the Memorial Hall. Mayor Govea called the meeting to order at 6:31 pm. Council members present were Wright, Farley, LaDuex, Hunter, Dickinson, and Maichel. Absent were Hampson and Walmann. Also present was City Manager Cawby, City Attorney Wetzler and Acting Secretary Sullivan. Visitors were Neil Phillips, Jarred, Gilmore & Phillips PA; Sam Johnson, BG Consultants; Collen Truelsen with the Osawatomie Graphic.

INVOCATION. Councilman Hunter gave the invocation.

CONSENT AGENDA. Approval of June 11th Agenda, approval of Minutes for May 14th & May 28th and approval of Appropriations Ordinance 2015-05. **Motion** made by LaDuex, seconded by Hunter to approve the amended Consent Agenda. Yeas: All.

COMMENTS FROM THE PUBLIC. None.

PRESENTATIONS. Neil Phillips of Jarred Gilmore & Phillips, PA (The City Auditor). Mr. Phillips presented the outcome of The City's Audit. Phillips reviewed the standards and procedures used for the City's audit. The City is in compliance the Cash Basis Law. The City has a carry over of 1.2 months. The goal he would like the City to set a goal of at least a 3-month carry over. Phillips reported that overall the City's performance under the audit went very well. **Motion** by Hunter, seconded by LaDuex to receive the audit report. Yeas: 5 Nay: 1

PUBLIC HEARINGS. None

UNFINISHED BUSINESS:

<u>Condemnation of 812 South Street.</u> The Trailer at 812 South Street has been demolished. The owner is making progress; the trailer is ready to be official taken off the condemnation list. Staff will prepare an official resolution for the next Council meeting.

<u>CDBG Revolving Loan Funds.</u> The City has not used this program in the past 20 years and we do not have any outstanding loans. The City Manager recommends the return of the money to the Kansas Department of Commerce since the program cannot be modified from its original form. **Motion** made by LaDuex, seconded by Hunter to discontinue our participation with the CDBG Revolving Loan. Yeas: All

NEW BUSINESS:

Appointments. None

<u>Proclamation for Kansas Business Appreciation Month.</u> Read by Karen LaDuex. **Motion** by Hunter, seconded by LaDuex to authorize The Mayor to sign the proclamation. Yeas: All.

Resolution 705; Waiver of GAAP Requirements for 2015. Resolution to waive the City from compliance with GAAP requirements and allow the City to continue to operate under the Kansas Cash Basis Law for the year 2015. Motion by LaDuex, seconded by Hunter to approve the Resolution which waives waive the GAAP requirement for 2015. Yeas: All.

Proposed Amendment to T-Mobile Lease Agreement. City Manager Cawby proposes an amendment to T-Mobile Lease Agreement which he has negotiated to allow a microwave tower installation on the east water tower, in addition to their current towers. As part of the agreement, the City will receive an increase in rent of \$250.00 month and T-Mobile will remove three antennae's abandoned by another user.

Motion by LaDuex, seconded by Hunter to approve the amendment to the T-Mobile Lease Agreement. Yeas: All.

<u>2015-2016 Health Insurance.</u> City Manager Cawby reported that the City will stay with its current health insurance plan currently provided by United Health Care. The increase for 2015-16, will be around 8.5% on medical, with no changes for vision and dental plans. The City Manager reports that he hears most employees are happy with the insurance plan the City is providing.

Review of Historical Financial Information. In preparation for the upcoming budget cycle, the City Manager reviewed recent historical financial information to show the budget trend over the last 10 years. The reports showed that total of funds were low in 2006 but since then, fund balances have increased. The City is budgeting and planning to work on the 2015 budget.

COUNCIL REPORTS:

Hunter: Read about the appointment of Chief Bob Butters and Assistant Chief Dave Ellis in the Osawatomie Graphic; happy to have them on board.

Maichel: Concerned about state legislation affecting the City and how our representatives are voting. House at 4th and Chestnut has large track hoe there, which hasn't moved since it started demolition and stopped. The reason she voted nay for the audit was because it was under the presentation heading on the agenda and not under new or old business.

MAYOR'S REPORT: Parade and Jamboree next week and they are still needing assistance or volunteers.

CITY MANGER'S REPORT: Sports Complex almost done, weather permitting. City has a list of nuisances that need to be looked at and our new ordinance will help.

ADJOURNMENT: Mayor called for adjournment, **Motion** by Hunter, seconded by LaDuex to adjourn. Yeas: All.

Osawatomie, Kansas. **June 25, 2015.** The Council Meeting was held in Memorial Hall. INVOCATION. Pastor Wayne Ova of Faith Baptist Church delivered the invocation.

CONSENT AGENDA: Approval of the June 25th Agenda. **Motion** by Hunter, seconded by LaDuex. Yeas: All.

PRESENTATIONS: Pastor Wayne Ova, Pastor of Faith Baptist Church in Osawatomie. He reported that he has been in Osawatomie for nearly 29 years. The Church has been busy with the congregation and did not get many programs going this summer.

COMMENTS FROM THE PUBLIC: None.

PUBLIC HEARINGS: None.

UNFINISHED BUSINESS:

Ordinance 3730; Authorizing Lease Purchase Agreement. The proposed ordinance would authorize a lease purchase agreement for the levee tractor and mower in the amount of \$76,261. City Manager Cawby reported that the City received five bids from five different banks for four, six and eight year terms. Cawby recommends the lowest bid at the 8-year term at a rate of 2.5%, which was bid by Citizens State Bank in Paola. Motion by LaDuex, seconded by Hampson. Yeas: All.

Resolution 706; Repealing Condemnation of 812 South Street. The proposed resolution repeals the condemnation of 812 South Street included in Resolution 691, adopted by the City Council. The owner has demolished the unsafe nuisance trailer and removed it from the lot. Motion by LaDuex, seconded by Hunter. Yeas: All.

<u>Concession Stand Change Order.</u> The concession building is complete but it had some small change orders. Since the changes were small, the City held them until the end of the project. The dollar amount of the change order is \$2,596. **Motion** by Hunter seconded by Dickinson to approve the change order as presented. Yeas: All.

Council Lady Maichel arrived at 6:42 pm.

NEW BUSINESS:

<u>Proposed Recreation Interlocal Agreement with USD 367</u>. City Manager Cawby presented a proposed agreement for the operation of Recreation programs by the new Recreation Commission through the School District. The Agreement includes the operation of the Sports Complex by the school, revised utility rates to be adopted by the City, and the City to transfer funds to USD 367 for 2015. Once both parties have approved the same version, the Agreement must be sent to the Kansas Attorney General's Office for approval. **Motion** by Hunter, seconded by LaDuex to approve the Agreement. Yeas: All.

Revised Golf Course Contract. City Manager Cawby presented a revised Golf Course Contract between the City and Maxim Golf Solutions, LLC. Bryan Minnis, CEO of Maxim Golf, and City Manager Cawby, discussed the revised agreement which reduced the amount paid to Maxim from \$2,500 per month

to \$1,250 per month. The revised Contract will allow the Golf Course to hire a full-time employee to manage the day to day business of the Clubhouse. This agreement would take effect July 1, 2015. The change will allow Maxim to spend more time on increasing revenue for the Course. **Motion** by LaDuex, seconded by LaDuex. Yeas: All.

<u>Police Car Purchases.</u> The City Manager requested approval for the City to purchase two used 2010 Chevy Impalas from a used police car dealership in Tampa Bay, Florida. The City will send qualified staff members to inspect the vehicles and bring them home if they meet appropriate standards. **Motion** by Hunter, seconded by LaDuex to approve the purchase of the two police cars, subject to inspection and approval by staff.

<u>Capital Improvements Program.</u> The Council reviewed the CIP requests of Department Heads and major project estimates presented by City Manager Cawby. The list will be reviewed by the City Manager and final recommendations will be made by the City Manager to the Council at the end of the budget process.

COUNCIL REPORTS:

Maichel: Felt the Jamboree went well.

Hampson: The interim Recreation Commission looked at two contractors for the proposed swimming pool to be built by the school.

MAYOR'S REPORT: Ice Cream Social July 13, 2015 at the Community Garden.

CITY MANGER'S REPORT: None.
