RESOLUTION 816 – DIRECTING STAFF TO ENTER INTO AN AGREEMENT BETWEEN THE CITY OF OSAWATOMIE AND BG CONSULTANTS FOR ENGINEERING SERVICES FOR WASTEWATER TREATMENT PLANT REPAIRS AND IMPROVEMENTS – Wastewater Treatment Plant Operator Bruce Hurt discussed some of the major issues at the wastewater plant such as harmful bacteria being released into the river due to equipment failures. These equipment failures need immediate attention to help us get back into compliance with the state. **Motion** made by LaDuex, seconded by Dickinson to approve Resolution 816 – Directing staff to enter into an agreement between the City of Osawatomie and BG Consultants for Engineering Services for Wastewater Treatment Plant Repairs and Improvements as presented. COUNCIL REPORTS.

Karen LaDuex ~ Library board met Monday evening and decided to take the book mobile under advisement at the special board meeting on October 5th. LaDuex praised the City Manager regarding the rental licensing program.

MAYOR'S REPORT ~ A tentative date of October 8, 2020 has been set for the Governor to attend the ribbon cutting at the Flint Hills Trail. Govea thanked council member Walmann and council member LaDuex along with the Osawatomie Trails Taskforce for their assistance in completing the trail. Govea has recently attended two events at the trail. It was exciting to see all the people.

Govea asked the council for their feedback on the Food Truck survey that will be sent out. Council member Caldwell liked the survey and said that Chris's Café said that their business has not been affected. There have been both some positive and some negative comments about the food trucks. Council member Wright thinks the food trucks have been successful and has received good feedback. Council member LaDuex thinks that as long as the food trucks feel it is to their advantage to come here then we should welcome them with open arms. Govea thanked Dee Leach for her efforts in securing food trucks through November in addition to her job. Govea also thanked Ed Beaudry, Dave Ellis and Sam Moon for staying late and answering questions of the landlords and getting the auditorium ready on a short turnaround and Bruce Hurt for all of his hard work at the Wastewater Plant. Thank you to all the City Staff who were out and about making sure that everybody gets counted in our community and to the City Council members for agreeing to take on this meaningful work of leaving our community a better place with their service. And last of all thank you to the landlords for their passion and persistence. Mid- America Regional Council approved the 2021 Planning Sustainable Places funding recommendation for City of Osawatomie. Mike Scanlon has been doing a great job putting together grant opportunities for the City.

CITY MANAGER & STAFF REPORTS.

Mike Scanlon ~ The MARC 2021 Planning Sustainable Places grant was approved and we have asked the planning commission and council to play a role in helping to organize a group of people to contribute ideas and thoughts for the project. This grant is hard to get because it is connected to transit. Our transit is people driving to the metropolitan area or driving around our community or region.

Staff has also been working on a KDOT Transportation Grant. We have made it through the first round and we need to submit the second round by November 6th. We are also applying for a USDA grant/loan for the trunk radio system that has been purchased on our behalf. Also looking at another USDA loan for rural recreation and for creating ecotourism that attracts people to your region or area. Once you get one grant it is easier to get the next because a lot of these programs depend on a planning effort that has started on the community level.

Several landlords have stopped by to talk, called or emailed. We have taken the time to listen to the landlords and when we get to the end, we will have a program that other communities will want to mirror.

Just a reminder that we will have a retirement party tomorrow for Jeff Edwards at 2:00 p.m. in the auditorium. There are also new banners at the trail thanks to Kari Bradley and Sam Moon helping to design them.

RESOLUTION No. 817

A RESOLUTION DECLARING THE ELIGIBILITY OF THE CITY OF OSAWATOMIE TO SUBMIT AN APPLICATION TO THE KANSAS DEPARTMENT OF TRANSPORTATION FOR USE OF TRANSPORTATION ALTERNATIVES PROGRAM FUNDS SET FORTH BY MAP-21 FOR THE "OSAWATOMIE SHARED-USE PATH CONSTRUCTION" PROJECT IN THE CITY OF OSAWATOMIE AND AUTHORIZING THE CITY MANAGER TO SIGN THIS APPLICATION.

WHEREAS, the City of Osawatomie, Kansas, has the legal authority to apply for, receive, and administer federal, state, and other monies through Home Rule Power under the Constitution of the State of Kansas and authorized by K.S.A. 12-1662, regarding the expenditure of federal-aid to public agencies; and

WHEREAS, the City of Osawatomie, Kansas, is submitting an application to the Kansas Department of Transportation for Transportation Alternatives (TA) Program funds in the amount of \$6,046,693.13 set forth by MAP-21 and as outlined in KDOT's Transportation Alternatives Program Guidance & Application Packet for 2022 and 2023; and

WHEREAS, the City of Osawatomie, Kansas, is participating as an eligible Project Sponsor in the Kansas Department of Transportation's TA Program set forth by MAP-21; and

WHEREAS, Federal monies are available under a TA Program set forth by MAP21, administered by the State of Kansas, Department of Transportation, for the purpose of creating and promoting the planning and development of active transportation facilities and programs in Kansas; and

WHEREAS, the City of Osawatomie, Kansas, acknowledges availability of the required local match of no less than 20% and the availability of funds to pay all upfront costs, since the TA Program is a cost reimbursement program; and

WHEREAS, the City of Osawatomie, Kansas, agrees to pay any costs that exceed the project amount if the application is selected for funding; and

WHEREAS, after appropriate public input and due consideration, the Governing Body of City of Osawatomie, Kansas, has recommended that an application be submitted to the State of Kansas for the Osawatomie Shared-Use Path Construction project.

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF OSAWATOMIE, KANSAS:

SECTION 1. That the City of Osawatomie, Kansas, does hereby authorize BG Consultants to submit an application to the Kansas Department of Transportation for TRANSPORTATION ALTERNATIVES PROGRAM funds set forth by MAP-21 on behalf of the citizens of City of Osawatomie, Kansas.

SECTION 2. That the City of Osawatomie, Kansas, hereby assures the Kansas Department of Transportation that sufficient funding for the Osawatomie Shared-Use Path Construction project is available, as the TRANSPORTATION ALTERNATIVES PROGRAM is a reimbursement program.

SECTION 3. That the City of Osawatomie, Kansas, hereby assures the Kansas Department of Transportation that sufficient funding for the operation and maintenance of the Osawatomie Shared-Use Path Construction project will be available for the life of the project.

SECTION 4. That the City of Osawatomie, Kansas, hereby assures the Kansas Department of Transportation that the City of Osawatomie, Kansas, will have title or permanent easement to the Osawatomie Shared-Use Path Construction project by the time of project letting, if necessary.

SECTION 5. That the Chief Project Sponsor of City of Osawatomie, Kansas, is authorized to sign the application to the Kansas Department of Transportation for TRANSPORTATION ALTERNATIVES PROGRAM funds set forth by MAP-21 on behalf of the citizens of City of Osawatomie, Kansas. The Chief Project Sponsor is also authorized to submit additional information as may be required and act as the official representative of the City of Osawatomie in this and subsequent related activities.

SECTION 6. That the City of Osawatomie, Kansas, hereby assures the Kansas Department of Transportation that the City of Osawatomie, Kansas, is willing and able to, if the Osawatomie Shared-Use Path Construction project is selected for funding, administer all activities involved with the Osawatomie Shared-Use Path Construction project.
