Osawatomie, Kansas. **September 11, 2014.** The Council meeting was held in Memorial Hall. Mayor Govea called the meeting to order at 6:32 p.m. Council members present were Dickinson, Hampson, Hunter, LaDuex, Maichel and Walmann. Absent was Farley. Also present were City Manager Cawby, City Attorney Wetzler and City Clerk Elmquist. Visitors were Doug Jenkins, Linda Hay, Renee Slinkard, Marti McDougal and Colleen Truelson.

INVOCATION. Councilmember Hunter delivered the invocation.

CONSENT AGENDA. Approval of September 11 Agenda, approval of the minutes of August 14 and August 28 Council Meetings, approval of Appropriation Ordinance 2014-8 and approval of WWTP Improvements Project Pay App 3. Motion made by LaDuex, seconded by Hunter to approve the Consent Agenda as presented. Yeas: All.

Presentations, Comments from the Public:

Reverend Marti McDougal, United Methodist Church, gave her presentation later in the meeting.

Unfinished Business:

RESOLUTION – SET HEARING FOR CONDEMNATIONS. At the June 12 City Council meeting Resolution No. 682 was approved setting a hearing for the August 14 meeting. Since the hearing date was missed, another resolution setting a new hearing date needs to be approved. Motion made by LaDuex, seconded by Dickinson to approve the resolution resetting the hearing of the seven condemnations to the November 13 Council meeting. Yeas: All. The Resolution was assigned No. 685.

New Business:

APPOINTMENTS – none

VACANCY COUNCIL. Mayor Govea said the nominating committee had selected Kirk Wright to fill the Council vacancy in Ward 2. Motion made by Hunter, seconded by LaDuex to authorize the appointment of Wright as Council member to Ward 2. Yeas: All.

PROCLAMATION – CONSTITUTION WEEK. The proclamation proclaims September 17 through 23, 2014 as Constitution Week asking the citizens to reaffirm the ideals the Framers of the constitution had by vigilantly protecting the freedoms guaranteed to us through this guardian of our liberties, remembering that lost rights may never be regained. The Marais des Cygnes Chapter of the Daughters of the American Revolution requested the proclamation with two members present. Motion made by Hunter, seconded by LaDuex to approve the proclamation. Yeas: All.

PROCLAMATION – REHABILITATION WEEK. The proclamation proclaims the week of September 21 through September 27, 2014 as Rehabilitation Week to honor Osawatomie Rehabilitation and Miami County Medical Center Rehabilitation Services and to encourage all citizens to recognize the significant contributions of rehabilitation professionals and to renew their commitment to people with disabilities and to the efforts of rehabilitative medicine to improve quality of life. Motion made by Hunter, seconded by LaDuex to approve the proclamation. Yeas: All.

Reverend Marti McDougal, United Methodist Church, said their after school program will start up in October and is every Tuesday. There was success in the summer feeding program serving 30-35 people. The Ministerial Alliance now has 10 churches involved. Their annual Thanksgiving community event will be held November 13. Her church will be the host but this year it will be held at the High School instead of at one of the churches. The Alliance is working on a new program. Hands On Oz will have the churches doing work in the community such as working on the parks, winterization & other

small jobs. September 27 and September 28 the United Methodist Church will be celebrating their 160th anniversary.

Farley arrived during the presentation at 6:44 p.m.

CONSIDER RECOMMENDATION TO REZONE 412 BROWN. CONSIDER RECOMMENDATION TO REZONE THE 400 BLOCK OF BROWN, NORTH SIDE.

Doug Jenkins requested his property at 412 Brown be rezoned from R-1 (Single Family) to R-2 (Two-Family and Higher Density Single Family) to allow his current 3,200 sq. ft. home to become a duplex. The Osawatomie Planning Commission held a public hearing February 27 to consider the above request and on June 11 the hearing was continued. The Planning Commission voted 4-0 to send a recommendation of denial of the request to the City Council. The reason for the denial was to not allow spot zoning as it would essentially nullify any future denial of spot zoning and render the City's zoning map useless. Motion made by Hunter, seconded by LaDuex to approve the Planning Commission's recommendation to deny the rezoning of 412 Brown. Yeas: All. Immediately following the denial of the motion on June 11, the Planning Commission recommended that a hearing be set to consider a proposal, by the Commission, to rezone the entire north side of the 400 block of Brown Avenue from R-1 (Single Family) to R-2 (Two-Family and Higher Density Single Family). This was recommended to accommodate the ability of some of the larger homes being turned into duplexes in this block. The Commission held the public hearing on August 20, 2014. All Commission members indicated that the City's zoning map needed to be redrawn. Staff indicated that redrawing the map without a plan would be counter-productive. Separate motions were made to approve and reject, with all ending in a 2-2 tie. By the Commission not passing a motion to approve, the recommendation is deemed to be considered a Motion made by Hunter, seconded by LaDuex to approve the Planning Commission's recommendation to reject the rezoning of the 400 block of Brown. Yeas: All. The Planning Commission was remanded to evaluate the 400 and 500 block of Brown, north side, and the 400 and 500 block of Parker, south side.

Council Reports:

LaDuex: The Kansas Anthropological Association will be returning tomorrow to do follow up work at the Adair Cabin dig site. They will be working through Sunday. The second in the series of medallions honoring the city's national historic sites are available. This one recognizes the five persons killed at the battle of Osawatomie and the Soldiers' monument.

Hunter: The cost of the medallion is \$10. The All For You community event is September 13.

Dickinson: The Boy Scouts Chili Feed is tomorrow night before the football game.

Hampson: The Parks & Recreation Committee discussed having additional activities. They will be doing another skate night and will again have table tennis. Should have bids on the building at the Sports Complex by the end of September.

Maichel: The Public Safety Committee met. Mayor Govea attended to give direction as to what their duties are. The Chamber of Commerce's Annual Dinner meeting is October 16. The Council members decided they would pay for a table.

STAFF AGENDA MEMORANDUM

DATE OF MEETING: October 9, 2014

AGENDA ITEM: Open and Concealed Carry Updates

PRESENTER: Don Cawby, City Manager

ISSUE SUMMARY: In 2013, the Legislature passed and Governor Brownback signed HB 2052 which authorized the carrying of concealed weapons in state and municipal buildings unless metal detectors and personnel are stationed at each public entrance. The legislation was in effect as of July 1, 2013, but it allowed cities time to assess buildings and make determinations by sending a waiver letter to the Attorney General. The City sent a letter for a six-month waiver in June of 2013, which provided us six months to develop security plans for each City owned building.

Then in December of 2013, the City passed Resolution 676 which exempted the City of Osawatomie from these requirements for four-year exemption from the law passed upon adopted security plans. To qualify for the exemption, the City Council adopted a resolution to exempt certain buildings and then sent a letter to the Attorney General making him aware of our action.

In 2014, the Legislature amended the law with HB 2578 which does several thing which affect local government operations:

First, it creates new prohibitions for municipalities which prohibits cities from require disclosure by municipal employees who possess concealed carry of handgun licenses. Municipalities cannot terminate, demote, discipline, or otherwise discriminate against an employee based on the employee's refusal to disclose the employee's status as a concealed carry license holder.

Second, the bill adds new posting requirements for buildings where the open carrying of firearms can be prohibited as authorized in this legislation. The new provision makes it a violation of this statute to carry an unconcealed firearm into a building that was conspicuously

posted according to the new requirements and posted in accordance with rules and regulations the bill required the Attorney General to adopt for concealed carry.

Third, cities and counties are permitted to adopt ordinances, resolutions, or regulations pursuant to the law pertaining to concealed handguns in public buildings (KSA 2013 Supp. 75-7c20) relative to the personnel policies governing concealed carry of handguns by city or county employees, so long as in compliance with this law.

COUNCIL ACTION NEEDED: Review and discuss two actions:

- 1. A motion to direct the City Attorney and City Clerk to draft a resolution which amends Resolution 676 to include open carry of firearms.
- 2. A motion to amend the City's Personnel Policies to include the following:

"The City prohibits all employees who enter City property from carrying a handgun, firearm, knife with blade in excess of four (4) inches in length, or other prohibited weapon of any kind, regardless of whether the person is licensed to carry the weapon or not. Any employee disregarding this policy will be subject to immediate termination and possible prosecution by the City.

The only exceptions to this policy will be:

- i. police officers, security guards or other persons who have been given consent by the City Manager to carry a weapon on the property;
- ii. carrying of a device or tool provided by the City to an employee for the purpose of performing their job duties, which if such device or tool was not provided by the City, might otherwise be considered a weapon;
- iii. keeping a legally possessed weapon in a lawful manner in a personal vehicle that is parked on City property.

Nothing in this policy shall be construed to create any duty or obligation on the part of the City to take any actions beyond those required of an employer by existing law."

STAFF RECOMMENDATION TO COUNCIL: Propose and approve the two motions.

House Bill 2578: Weapons Regulation Preemption

On July 1, 2014, HB 2578 became law and municipalities began to adjust to the new realities of weapon regulation in the state of Kansas. We have had several inquiries from member cities concerning this new law. Here are a few of those questions and our recommendations.

How does this affect our building(s) that has/have been exempted under K.S.A. 2013 Supp. 75-7c20?

HB 2578 does not affect K.S.A. 2013 Supp. 75-7c20 when it comes to exempting a public building from the adequate security measures for four years. If a municipality exempted a building and is thus prohibiting conceal-carry in a public building, it can continue to do so.1 In addition, the open carry of firearms is also prohibited in the public building if the four year exemption is in place and proper signage is used.

Can we regulate the use of firearms by our employees?

It is the League's interpretation that under HB 2578, cities can establish personnel policies that:

- · Prohibit employees from the open carry of firearms while performing work for the city.
- Prohibit employees from conceal-carry in city vehicles and while working outside of public buildings.
- Require employees who conceal-carry to have the handgun under their control at all times.
- Prohibit employees from conceal-carry in a public building if:
 - (1) The building has a four year exemption pursuant to K.S.A. 75-7c20; or
 - (2) The building has adequate security and the employee does not enter through a door with restricted access.

Can we ask an employee if they have a conceal-carry license?

There is no prohibition against asking; however, the employee is under no obligation to answer that question. A municipality cannot discipline an employee for refusing to answer the question. A municipality cannot maintain any records concerning an employee's conceal-carry status.

Can we prevent a home business that sells firearms?

A municipality cannot enforce an ordinance that restricts the sale of firearms by an individual holding a federal firearms license in areas where other commercial goods are sold. In other words,

Summary of Kansas Attorney General's Opinion No. 2014-14

A person may not openly carry any firearm into a building that is lawfully posted as prohibiting open carry. Under Kansas law, a person may transport a loaded firearm in a vehicle, regardless of whether the person is licensed to carry a concealed handgun, and regardless of whether the loaded firearm is stored in a container or transported in plain view. Effective July 1, 2014, a city or county may not enforce local laws regulating the transportation of a firearm in a vehicle.

Federal law prohibits a person not licensed to carry a concealed handgun from possessing or transporting a loaded firearm in a school zone, except on private property. However, a Kansas concealed carry licensee may not carry a concealed handgun into any school building posted as prohibiting concealed carry.

this business cannot be treated any differently than any other commercial business.

Can a city enforce an ordinance regulating knives?

No. HB 2578 eliminated a city's ability to enforce any ordinance regulating knives. In 2013 the legislature left open the possibility to enforce ordinances that were already adopted by a city but, this new law makes it clear that there can be no enforcement of those prior ordinances. A city governing body also cannot regulate knives within public buildings.2

Can a city prohibit the open carry of firearms in a public building?

The Attorney General has issued temporary rules and regulations and is currently accepting public comment. Under the temporary rules the open carry of firearms can be prohibited in a public building two ways:

- (1) If the building is exempt pursuant to K.S.A. 2013 Supp. 75-7c20, or if adequate security measures are provided,3 the current sign now prohibits conceal-carry and the open carry
- (2) If the new sign in the shape of an octagon has the words, "The open carrying of firearms in this building is prohibited," and is properly placed on the entrances to the public building.

It is the recommendation of the League that if a governing body wants to have the no open carry signs placed on public buildings that the decision be made by a motion and majority vote. The rules and regulations concerning proper signs for public and private buildings can be found at http://ag.ks.gov/docs/default-source/ documents/2014-temporary-sign-regulations.pdf?sfvrsn=2.

The bill also makes it unlawful to possess a firearm "while under the influence of alcohol or drugs, or both, to such a degree as to render such person incapable of safely operating a firearm." This portion of the bill creates a procedure similar to the DUI statutes.5 Additionally, a city or county will no longer be able to implement or administer a firearms buyback program and cannot regulate the open carry of firearms other than the exceptions described above.

The reality is that HB 2578 is a law that may affect areas of municipal government that have not even been thought of yet. As local governments move forward, it will be important to educate frontline employees about the changes. If there become issues of concern surrounding this new law, it will be important for local government officials to discuss those concerns with their Representatives and Senators.

RESOLUTION NO. 676

A RESOLUTION EXEMPTING, UNTIL JANUARY 1, 2018, CERTAIN IDENTIFIED OSAWATOMIE MUNICIPAL BUILDINGS FROM THE REQUIREMENTS OF 2013 KAN. SESS. LAWS 551, CHAPTER 105, NEW SECTION 2, WHICH PRECLUDES KANSAS MUNICIPALITIES FROM PROHIBITING THE CARRYING OF CONCEALED HANDGUNS INTO CITY BUILDINGS.

WHEREAS, the 2013 Kansas Legislature adopted New Section 2 of the 2013 Senate Substitute for House Bill No. 2052, which in part requires Kansas municipalities to allow carrying of concealed handguns in municipal buildings beginning on July 1, 2013 ("Section 2"); and

WHEREAS, Senate Substitute for House Bill No. 2052 is currently found at 2013 Kansas Session Laws 551, Chapter 105 ("the Law"); and

WHEREAS, Section 2(i) of the Law provides that municipalities are authorized to exempt municipal buildings for a period of four years beginning on January 1, 2014, from the requirements that municipalities allow the carrying of concealed handguns into municipal building; and

WHEREAS, pursuant to the authority set forth in Section 2(i) of the Law, the City of Osawatomie, desires to exempt its municipal buildings from the requirements that municipalities allow the carrying of concealed handguns into municipal buildings for a period of four years beginning on January 1, 2014.

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF OSAWATOMIE, KANSAS:

SECTION ONE. MUNICIPAL BUILDINGS EXEMPT. Pursuant to the authority set forth in Section 2(i) of the Law, the City of Osawatomie, Kansas hereby exempts the municipal buildings listed below from the provisions of Section 2 of the Law relating to municipalities prohibiting the carrying of a concealed handgun in municipal buildings as authorized by the personal and family protections act. It is the intent of the City that the exemption set forth herein shall extend for a period of four years beginning on January 1, 2014. As required by Section 2(i) of the Law, the below list of municipal buildings includes a legal description of the building locations.

CITY HALL & AUDITORIUM

439 Main Street

Legal Description: All buildings located on LOTS 8,9 & 10, BLOCK 31, Original Survey to the City of Osawatomie, Miami County, Kansas

POLICE DEPARTMENT

- The Governing Body of the City has determined that exempting its municipal buildings from the requirements of Section 2 of the Law is in the best interest of the community based on public safety issues related to the carrying of concealed firearms in City buildings.
- The City has a workplace violence and weapons policy that prohibits its employees from introducing firearms and dangerous weapons into the workplace.
- The four year exemption will afford the City additional time to review public safety issues related to the carrying of concealed firearms in City buildings.
- A security plan has been developed for the buildings being exempted which supplies adequate security to the occupants of the buildings and merits the prohibition of the carrying of a concealed handgun as authorized by the personal and family protection act.

SECTION 3. A security plan has been developed for the buildings being exempted which supplies adequate security to the occupants of the buildings and merits the prohibition of the carrying of a concealed handgun as authorized by the personal and family protection act. The prohibition shall continue until expiring after December 31, 2017.

SECTION 4. A copy of the security plan shall be maintained by the City Clerk and will be provided to the Kansas Attorney General or local law enforcement upon request. The security plan is not subject to disclosure under the Kansas open records act.
