REGULAR MEETING – November 20, 2014 REGULAR MEETING – December 11. 2014 Osawatomie, Kansas. **October 9, 2014.** The Council meeting was held in Memorial Hall. Mayor Govea called the meeting to order at 6:32 p.m. Council members present were Farley, Hampson, Hunter, LaDuex, Maichel and Wright. Absent was Dickinson and Walmann. Also present were City Manager Cawby, City Attorney Wetzler and City Clerk Elmquist. Visitors were Shelagh Wright, Garrett Nordstrom, Gabe Pffeffercorn, Blake Madden, Ken Tyson, Dan Macek and Colleen Truelson.

INVOCATION. Interim Pastor Ken Tyson, Vineyard of Hope.

CONSENT AGENDA. Approval of October 9 Agenda, approval of the minutes of September 11 and September 25 Council Meetings, approval of Appropriation Ordinance 2014-9 and approval of WWTP Improvements Project Pay App 4. **Motion** made by LaDuex, seconded by Hunter to approve the Consent Agenda as presented. Yeas: All.

Presentations, Comments from the Public:

Pastor Ken Tyson, has served as interim for $3\frac{1}{2}$ years. Sunday he will be installed as their fulltime pastor. He began his ministry helping eight substance abusers recover. Now the ministry for substance abusers is at a 141 recovery rate. There are several other outreach things they do at the church.

SHELTER HOUSE CHIMNEYS. PW Director Blake Madden thought that the chimneys needed to come down. Gabe Pffeffercorn, Pffeffercorn & Baldridge Engineering, was asked to look at the structure. He know it needs to be addressed but being historic it is a sensitive issue. The structure is in good shape except the chimneys are splitting and falling apart. Depending on what is done it will cost between \$5,000 to \$10,000. The options are: 1) take the chimneys down, 2) fill them in using volunteers or 3) complete restoration. There was discussion about how far to take the chimneys down. Pffeffercorn recommended the most economical option would be to take down the chimneys and put on a wood roof to keep the historical value in the future. The immediate need is the roof has to be put on. Dan Macek says the Rotary Club has the money to do the option of taking the chimneys down and putting the roof on. Pffeffercorn said making the chimneys functional is not an option. Then they need to be filled in or taken down. Motion made by Hampson, seconded by Maichel to take the chimneys down to roof level so they are out of the way of putting the roof up. Yeas: All. The roof will be made of steel with regular wooden trusses.

Public Hearings:

CONSIDERATION OF CDBG GRANT APPLICATION FOR OSAWATOMIE MAIN STREET IMPROVEMENTS – PHASE 1. Mayor Govea opened the hearing at 7:09 p.m. The project will cost \$1.1 million. The grant application will request \$400,000. The deadline to file for the grant is November 3. There were no comments from the public. The hearing was closed at 7:11 p.m.

Unfinished Business:

RESOLUTION CERTIFYING LEGAL AUTHORITY TO APPLY FOR CDBG GRANT AND AUTHORIZE MAYOR TO SIGN ALL NECESSARY DOCUMENTS. At the June 12 City Council meeting Resolution No. 682 was approved setting a hearing for the August 14 meeting. Since the hearing date was missed, another resolution setting a new hearing date needs to be approved. **Motion** made by LaDuex, seconded by Dickinson to approve the resolution resetting the hearing of the seven condemnations to the November 13 Council meeting. Yeas: All. The Resolution was assigned No. 686.

RESOLUTION ASSURING OPERATION AND MAINTENANCE OF IMPROVEMENTS. Motion made by Maichel, seconded by Hunter to approve to approve the Resolution. Yeas: All. The Resolution was assigned No. 687.

RESIDENTIAL ANTI-DISPLACEMENT & RELOCATION ASSISTANCE PLAN. Motion made by Hunter, seconded by Maichel to authorize the Mayor to sign the plan. Yeas: All.

WASTE WATER TREATMENT PLANT PROJECT - CHANGE ORDER NO. 2. The

increase of \$735.73 to the contract is to fix a design flaw at the plant. The stop gate style will change and BG Consultants will reduce their bill by the amount of the change order. **Motion** made by LaDuex, seconded by Hunter to approve the change order for an additional \$735.73. Yeas: All.

WASTE WATER TREATMENT PLANT PROJECT – CHANGE ORDER NO. 3A. The increase of \$4,615.28 to the contract is due to the additional cost of aluminum covers over the Parshall flume. The change in the contract price including Change order No. 2 and 3A is \$632,473.79 **Motion** made by LaDuex, seconded by Hunter to approve the change order for an additional \$4,615.28. Yeas: All.

New Business:

APPOINTMENTS: none

WEAPONS REGULATION PREEMPTION. The passage of Resolution 676 exempts the City from HB 2052 on open carry of firearms in public buildings. The Legislature has amended the law with HB 2578 which affects local government operations in several ways. First, cities are prohibited from requiring disclosure by municipal employees who possess concealed carry of handgun licenses. Municipalities cannot terminate, demote, discipline, or otherwise discriminate against an employee based on the employee's refusal to disclose the employee's status as a concealed carry license holder. Second, there are new posting requirements for buildings where the open carrying of firearms can be prohibited. It is a violation of the statute to carry an unconcealed firearm into a building that was conspicuously posted. Third, cities are permitted to adopt a resolution pursuant to the law pertaining to concealed handguns in public buildings relative to the personnel policies governing concealed carry of handguns by city employees, so long as in compliance with this law. The only exceptions to this policy will be: 1) police officers, security guards or other persons who have been given consent by the City Manager to carry a weapon on the property; 2) carrying of a device or tool provided by the City to an employee for the purpose of performing their job duties, which if such device or tool was not provided by the City, might otherwise be considered a weapon; and 3) keeping a legally possessed weapon in a lawful manner in a personal vehicle that is parked on City property. Nothing in this policy shall be construed to create any duty or obligation on the part of the City to take any actions beyond those required of an employer by existing law. Motion made by LaDuex, seconded by Wright to authorized the City Attorney and City Clerk to draft a resolution which amends Resolution 676 to include open carry of firearms Yeas: All. Motion made by LaDuex, seconded by Farley to amend the City's Personnel Policies to include the following: "The City prohibits all employees who enter City property from carrying a handgun, firearm, knife with blade in excess of four (4) inches in length, or other prohibited weapon of any kind, regardless of whether the person is licensed to carry the weapon or not. Any employee disregarding this policy will be subject to immediate termination and possible prosecution by the City." Yeas: All.

PURCHASE OF CRACK SEALING MACHINE. Two bids were received for the purchase of a new crack sealing machine.

Staff is recommending the Crafco SS 125 Melter for \$38,575. Staff used the Crafco machine which was borrowed from the City of Ottawa. Funding for the machine will come out of the savings from not doing chip sealing this year. The use of the machine will provide more value for the longevity of streets than will chip sealing. **Motion** made by LaDuex, seconded by Hunter to approve the purchase of the Crafco SS 125 for \$38,575.00. Yeas: All.

Hampson: The Parks & Recreation Committee's fall sports are finishing up. There was good representation. The Committee is getting ready for the winter sports.

Maichel: Said that Hampson is one of the new Chamber of Commerce board members.

Mayor's Report:

He was asked to lead a round table discussion on chickens and farm animals at the LKM's annual conference in October along with the animal control officer from Newton and someone from the Humane Society.

City Manager's Report:

Cash Flow Report. Informed the Council the reason there is a negative amount in the CIP-Sewer Fund is that the City has to pay the contractor and then KDHE reimburses the City.

Sports Complex concession stand and Police Station sally port. Did an RFQ to see the interest and then do the designs with the contractor.

5th Street Waterline. The work is not going as quickly as they thought. They've had to deal with abandoned water lines and the rain.

Street Patching. Work is being done where the water leaks have occurred.

Meter Reader/Nuisances Officer. Kyle Glaser has started work. He is learning the meter reading. Also, he's learning about nuisances from the Police Department's former nuisances officer.

Power Supply Task Force. A meeting is scheduled for October 31.

Planning Commission. A meeting is scheduled at the end of the month. They are also dealing with a vacancy.

Interim Public Works Director/Assistant City Manager. With the new Public Works Director on board Andy Haney has been working on projects for City Manager Cawby. Haney put together a draft of the personnel regulations with City Manager Cawby's direction. They have been meeting with an employee committee to review. An RFP for operation of the Golf Course was desired by the Golf Course Committee. They want to know if there really is a desire out there for someone to lease the Golf Course. By the end of the month Haney will be transitioning out. He may be asked for assistance on a task in the future.

Maichel: Attended the League of Kansas Municipality's Annual Conference. The information needs to be brought to the Council from those that attended.

Mayor's Report:

At this year's League Conference the Mayor, Newton's animal control officer, and a Humane Society representative led 3 different roundtable discussion groups on "Backyard Chickens & Other Animal Issues." The Mayor gained a lot of information from the discussions and will be forming a chicken committee.

City Manager's Report:

Nuisances. Nuisance Officer Kyle Glaser is working on strategies for dealing with nuisances. The focus will be one issue at a time. Glaser has prepared a press release informing everyone that in November the concentration will be on vehicles and junk vehicles. Some nuisance violation letters have already been sent out. Violators have 10 days to abate the nuisance. An appeal can made to the Hearing Officer, the Mayor. Very happy that someone has stepped up to the plate.

Workers' Compensation. A gold star rating was received on the City's workers' compensation for 2015. The City had slipped out of the discount and had only previously gotten a 1% discount. With the changes made by the City employees' Safety Committee, the City jumped to the top level and will receive at 5% discount for next year. Most importantly, the Committee's continued work should reduce claims and issues over time, also helping the rates drop.

Police Department and Sports Complex buildings. An RFQ was distributed for construction of the PD's sally port and the Sports Complex concession stand..

Golf Course. An RFP was distributed for management of the Golf Course or working with the City. A hybrid may created.

Rezoning 400 block of Brown. The Planning Commission will be meeting to further discuss the rezoning since the City Council sent it back to them.

Power Supply. The Power Supply Task Force will be having another meeting.

Park Fountain. The fountain in John Brown Park needs to be brought up to Code. Quotes will be obtained from contractors or the staff may be able to do the work.

AN ORDINANCE VACATING A CERTAIN ALLEY LOCATED IN THE 1100 BLOCK OF SIXTH STREET IN THE CITY OF OSAWATOMIE, MIAMI COUNTY, KANSAS.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF OSAWATOMIE KANSAS, as follows:

SECTION ONE: That the City of Osawatomie, Kansas, a city of the second class, under and by virtue of the provisions of K.S.A. 14-423, for good cause, does hereby declare that the following described alley, situated in the City of Osawatomie, Miami County, Kansas, be vacated to-wit:





PRESENTER:	Ryan Crowley, Parks & Recreation Director Blake Madden, Public Works Director

ISSUE SUMMARY: Near the end of September, the City issued a request for qualifications for construction services to construct a new concessions and bathroom building at the Sports Complex which would allow the City to meet the requirements for a food service license from the Kansas State Department of Agriculture. In mid-October, two contractors, Triangle Builders, LLC and Wendt Construction, were shortlisted for interviews and discussion about the project. Proposals and bids were then received from the two contractors which were strictly for construction of and finish work within the new building. A majority of the site and utility work for the building will be performed by City staff in an effort to reduce costs. The bids received were as follows:

Triangle Builders, LLC \$150,000

Wendt Construction \$105,000

The selection committee, which included Ryan Crowley, Ted Bartlett, Blake Madden, and Don Cawby, reviewed each proposal and is recommending that the City enter into a contract with Wendt Construction for construction of the new building. In addition to the lower cost, the committee feels that Wendt Construction will be more accommodating to the City by allowing City staff to perform work in conjunction with their work and alongside their crew. Attached are proposals submitted by each contractor.

COUNCIL ACTION NEEDED: Review the submittals and bids of the new concession stand & bathroom structure.

STAFF RECOMMENDATION TO COUNCIL: Approve the selection of Wendt Construction and approve the City to draft a contract with Wendt Construction based upon this bid.

ORDINANCE NO.

AN ORDINANCE REGULATING TRAFFIC WITHIN THE CORPORATE LIMITS OF THE CITY OF OSAWATOMIE, KANSAS; INCORPORATING BY REFERENCE THE "STANDARD TRAFFIC ORDINANCE FOR KANSAS CITIES" EDITION OF 2014; AMENDING CHAPTER 14, ARTICLE 1, OF THE CITY OF OSAWATOMIE MUNICIPAL CODE; AND REPEALING ORDINANCE NO. 3721.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF OSAWATOMIE, KANSAS:

<u>SECTION ONE:</u> Article 1 of Chapter 14 of the City of Osawatomie Municipal Code is hereby amended to read as follows:

14-101. INCORPORATING STANDARD TRAFFIC ORDINANCE. There is hereby incorporated by reference for the purpose of regulating traffic within the corporate limits of the City of Osawatomie, Kansas, that certain standard traffic ordinance known as the "Standard Traffic Ordinance for Kansas Cities," Edition of 2014, prepared and published in book form by the League of Kansas Municipalities, Topeka, Kansas, save and except such articles, sections, parts or portions as are hereafter omitted, deleted, modified or changed. One copy of said Standard Traffic Ordinance shall be marked or stamped "Official Copy as Incorporated by the Code of the City of Osawatomie," with all sections or portions thereof intended to be omitted or changed clearly marked to show any such omission or change and to which shall be attached a copy of this Ordinance, and filed with the City Clerk to be open to inspection and available to the public at all reasonable hours. The Police Department, Municipal Judge and all administrative departments of the City charged with the enforcement of the Ordinance shall be supplied, at the cost of the City, such number of official copies of such Standard Traffic Ordinance similarly marked, as may be deemed expedient.

14-102. SAME; AMENDMENTS. Section 33 of the Standard Traffic Ordinance as adopted is amended to read as follows:

Sec. 33. Maximum Speed Limits.

- (a) Except as provided in subsection (b) and except when a special hazard exists that requires lower speed for compliance with K.S.A. 8-1557, and amendments thereto, the limits specified in this subsection or established as authorized by law shall be maximum lawful speeds, and no person shall operate a vehicle at a speed in excess of such maximum limits:
 - (1) In any business district, 20 miles per hours;
 - (2) In any urban district, 30 miles per hour;
 - (3) On any separated multilane highway, as designated and posted by the secretary of transportation 70 miles per hour;
 - (4) On any county or township highway, 55 miles per hour; and

- (b) No person shall drive a school bus to or from school, or interschool or intra-school functions or activities, at a speed in excess of the maximum speed limits provided in subsection (a), except that the board of education of any school district may establish by board policy lower maximum speed limits for the operation of such district's school buses. The provisions of this subsection relating to school buses shall apply to buses used for the transportation of students enrolled in community colleges or area vocational schools, when such buses are transporting students to or from school, or functions or activities. (K.S.A. Supp. 8-1558)
- (c) The maximum speed limits in this section may be altered as authorized in K.S.A 8-1559 and K.S.A 8-1560, and amendments thereto.
- (d) The Governing Body having determined upon the basis of a traffic investigation that the speed limits permitted under state law and Section 33 of the Standard Traffic ordinance are less than reasonable and safe on some streets and are more than reasonable and safe on other streets, and does determine and declare that the speed limit (except when a special hazard exists that requires lower speed for compliance with Section 32) on the streets hereinafter set forth be the limits specified in this section, and no person shall drive a vehicle at a speed in excess of such maximum limits:
 - (1) Speed not in excess of 20 miles per hour shall be lawful on the following streets:
 - (A) Main Street between 15th Street and 18th Street.

14-103. SAME; AMENDMENTS. Section 93 of the Standard Traffic Ordinance as adopted is amended to read as follows:

Sec. 93. Parking Disabled and Other Vehicles.

- (a) No person shall park or store any farm machinery, trailer or semi-trailer of any kind, or parts of the same, or any dead, damaged or disabled motor vehicle or farm machinery, trailer or semi-trailer of any kind, in the roadway of any highway, or between the property line or sidewalk and the curb line of any street. No person shall park or store any operable motor vehicle between the property line or sidewalk and the curb line of sidewalk and the curb line of any street except on a designated driveway.
- (b) A person shall not use the public highway to abandon vehicles or use the highway to leave vehicles unattended in such a manner as to interfere with public highway operations. When a person leaves a motor vehicle on a public highway or other property open to use by the public, the city having jurisdiction of such highway or other property open to use by the public, after 48 hours or when the motor vehicle interferes with public highway operations, may remove and impound the motor vehicle. (K.S.A. 8-1102)

14-104. TRAFFIC INFRACTIONS AND TRAFFIC OFFENSES. (a) An ordinance traffic infraction is a violation of any section of this ordinance that prescribes or requires the same behavior as that prescribed or required by a statutory provision that is classified as a traffic infraction in K.S.A. 8-2118.

(b) All traffic violations which are included within this article, and which are not ordinance traffic infractions as defined in subsection (a) of this section, shall be considered traffic offenses. (Ord. 3632, Sec. 5; Code 2008)

14-105. PENALTY FOR SCHEDULED FINES. The fine for violation of an ordinance traffic infraction or any other traffic offense shall be established by the Municipal Judge. (Code 2008)

14-106. AMENDMENTS. Section 23 of the Standard Traffic Ordinance as adopted is amended to read as follows:

Sec. 23. Accident Involving Death or Personal Injuries; Penalties.

- (a) The driver of any vehicle involved in an accident resulting in injury *to*, great bodily harm to or death of any person or damage to any attended vehicle or property shall immediately stop such vehicle at the scene of such accident, or as close thereto as possible, but shall then immediately return to and in every event shall remain at the scene of the accident until the driver has fulfilled the requirements of Section 25.
- (b) A person who violates subsection (a) when an accident results in:
 - (1) Total property damages of less than \$1,000 shall be punished as provided in Section 201.
 - (2) Injury to any person or total property damages in excess of \$1,000 or more shall be punished by imprisonment for not more than one year or by a fine of not more than \$2,500, or by both such fine and imprisonment.
- (c) The driver shall comply with the provisions of section 26.1. (K.S.A. Supp. 8-1602)

14-107. AMENDMENTS. Section 200 of the Standard Traffic Ordinance as adopted is amended to read as follows:

Sec. 200. Motor Vehicle Liability Insurance.

- (a) Every owner shall provide motor vehicle liability insurance coverage in accordance with the provisions of the Kansas Automobile Injury Reparations *Act*, K.S.A. 40-3101, *et seq.*, for every motor vehicle owned by such person, unless such motor vehicle: (1) Is included under an approved self-insurance plan as provided in K.S.A. 40-3104(f); (2) is used as a driver training motor vehicle, as defined in K.S.A. 72-5015, and amendments thereto, in an approved driver training course by a school district or an accredited nonpublic school under an agreement with a motor vehicle dealer, and such motor vehicle liability insurance coverage is provided by the school district or accredited nonpublic school; (3) is included under a qualified plan of self-insurance approved by an agency of the state in which such motor vehicle is registered and the form prescribed in subsection (b) of K.S.A. 40-3106, and amendments thereto, has been filed; or (4) is expressly exempted from the provisions of the Kansas Automobile Injury Reparations Act.
- (b) An owner of an uninsured motor vehicle shall not permit the operation thereof

upon a highway or upon property open to use by the public, unless such motor vehicle is expressly exempted from the provisions of the Kansas Automobile Injury Reparations Act. of any such prior conviction shall be guilty of a violation of this ordinance and subject to a fine of not less than \$800 nor more than \$2,500 or by imprisonment for a term not to exceed one year, or both such fine and imprisonment. (K.S.A. Supp. 40-3104)

<u>SECTION THREE:</u> EXISTING SECTION REPEALED. Chapter 14, Article 1 of the Code of the City of Osawatomie as adopted prior to the passage of this Ordinance is hereby repealed.

<u>SECTION FOUR:</u> EFFECTIVE DATE. This ordinance shall take effect and be in force from and after its publication in the official City Newspaper.

OFFICIAL PUBLIC SAFETY COMMITTEE REQUEST FOR DESIGNATION OF SNOW ROUTES November 3, 2014

This letter will serve as an official Osawatomie Public Safety Committee Recommendation for designation of emergency snow routes during hazardous conditions. This recommendation will include a request to post signs along the snow routes that advise residences that parking will only be allowed on one side of the street. In addition, Committee recommends additional communications in the forms of code red warnings, letters to residences, notices in the newspaper, etc., to inform residents of these changes, where to park and results if there is no compliance. Committee recommends the following routes be designated as snow routes:

Main Street: Beginning at exit from 169 hwy., to 18th Street.

12th Street: Beginning at 12th and Main to Parker (in front of OHS)

Parker Ave.: Beginning at 12th and Parker to Trojan Elementary School

Brown Ave.: Beginning at Oneal St., to 12th Street

1st Street: Beginning at Carr Ave., to Chestnut Ave.

4th Street: Beginning at Carr Ave., to the end of 4th Street past Kelly Ave.

6th Street: Beginning at Derrick Jensen Dr. to Kelly Ave.

8th Street: Beginning at the Marais Des Cygnes bridge to Main Street.

9th Street: Beginning at Main Street to South St.

In addition, there may be State statutes prohibiting parking in an intersection, which is another reason for the Committee's proposal.
