WASTE MANAGEMENT – after reviewing the contract Smith, Beaudry and Seamands met with Waste Management and discussed some things that they were concerned about. We will continue to look at the contract and see if we can find a way to make things run smoother.

NOISE ORDINANCE – Stuterville and Smith are gathering other noise ordinances to compare to ours to see if we can use to tighten up our noise ordinance.

NUISANCE OFFICER – As of October 19<sup>th</sup>, Ellis will be the Nuisance Officer and Stuterville will be the Police Chief. They will be sworn in at the next council meeting.

Govea thanked Ellis for doing a great job as Chief. Ellis thanked them for the opportunity.

FIX-IT FORM – Borth has created a spreadsheet to track the information received from the fix – it forms and how the complaints are being addressed. The form now works on mobile devices and you can now also add pictures.
